Health Workforce in Nevada – 2025 is a publication from the Nevada Health Workforce Research Center in the Office of Statewide Initiatives at the University of Nevada, Reno School of Medicine.

The mission of the Office of Statewide Initiatives is to improve the health of Nevadans through statewide engagement, education, and research.

The vision of programs in the Office of Statewide Initiatives is to promote health and prevent disease, as well as provide technical assistance that increases access to high-quality health care for all Nevadans.

The purpose of the Nevada Health Workforce Research Center is to improve the collection and analysis of data on health workforce supply and demand to enhance health workforce planning and development in Nevada.

Health Workforce in Nevada

Overview and Highlights

Health Workforce in Nevada – 2025 provides current data on the supply and geographic distribution of physicians, nurses, and other health care workers in Nevada. This report was prepared by the Nevada Health Workforce Research Center in the Office of Statewide Initiatives at the University of Nevada, Reno School of Medicine.

Drawing on a wide range of state and federal data sources, the data contained in this edition of *Health Workforce in Nevada* point to progress Nevada has made in expanding the supply of health care workers across the state, including impressive gains in advance practice registered nurses, licensed clinical social workers, marriage and family therapists, and physician assistants. However, data contained in this year's report also underscore persistent, widespread shortages of health care workers – shortages that impede access to health care for thousands of Nevadans despite an improving post-pandemic economy and significant gains in health insurance coverage over the past decade in Nevada.

The health workforce trends documented in *Health Workforce in Nevada* will require state and local leaders to pursue policy measures to increase the supply of health professionals, improve the diversity of the state's health workforce, and address the geographic maldistribution of health workers in Nevada.

Health Workforce in Nevada – 2025 is organized into the following three sections:

- Current and Projected Employment in Health Care Industries in Nevada. Figures 1 through 9 provide updated information from the Nevada Department of Employment, Rehabilitation, and Training and the United States Bureau of Labor Statistics on occupational and industry trends in the health sector in Nevada (see pages 5-13). This section of the report also provides estimates of the number of additional jobs needed in Nevada to meet national per capita averages for selected health care occupations and industries within the health care and social assistance sector of the Nevada economy.
- Health Professions Licensure Trends in Nevada. Figures 10 through 95 provide current data on health workforce trends by county and region of Nevada over the past decade utilizing data from state boards charged with licensing and regulating health professionals in Nevada (see pages 15-59). This section also provides information on per capita change in licensure counts utilizing data from the Nevada State Demographer's Office and the United States Census Bureau. These data reveal steady growth in the number of licensees for most health care occupations – progress that is more modest when accounting for population growth in Nevada over the past decade.

- Primary Care, Dental, and Mental Health Professional Shortages in Nevada. Figures 96 to 106 provide updated information on the magnitude of health professional shortages in Nevada utilizing current data and shortage designations from the federal Health Resources and Services Administration (see pages 61-72). This section also provides county-level data on the estimated number of Nevadans currently living in a health professional shortage area.

Highlights and Key Findings

Highlights and key findings from Section 1 in the *Health Workforce in Nevada – 2025* report include:

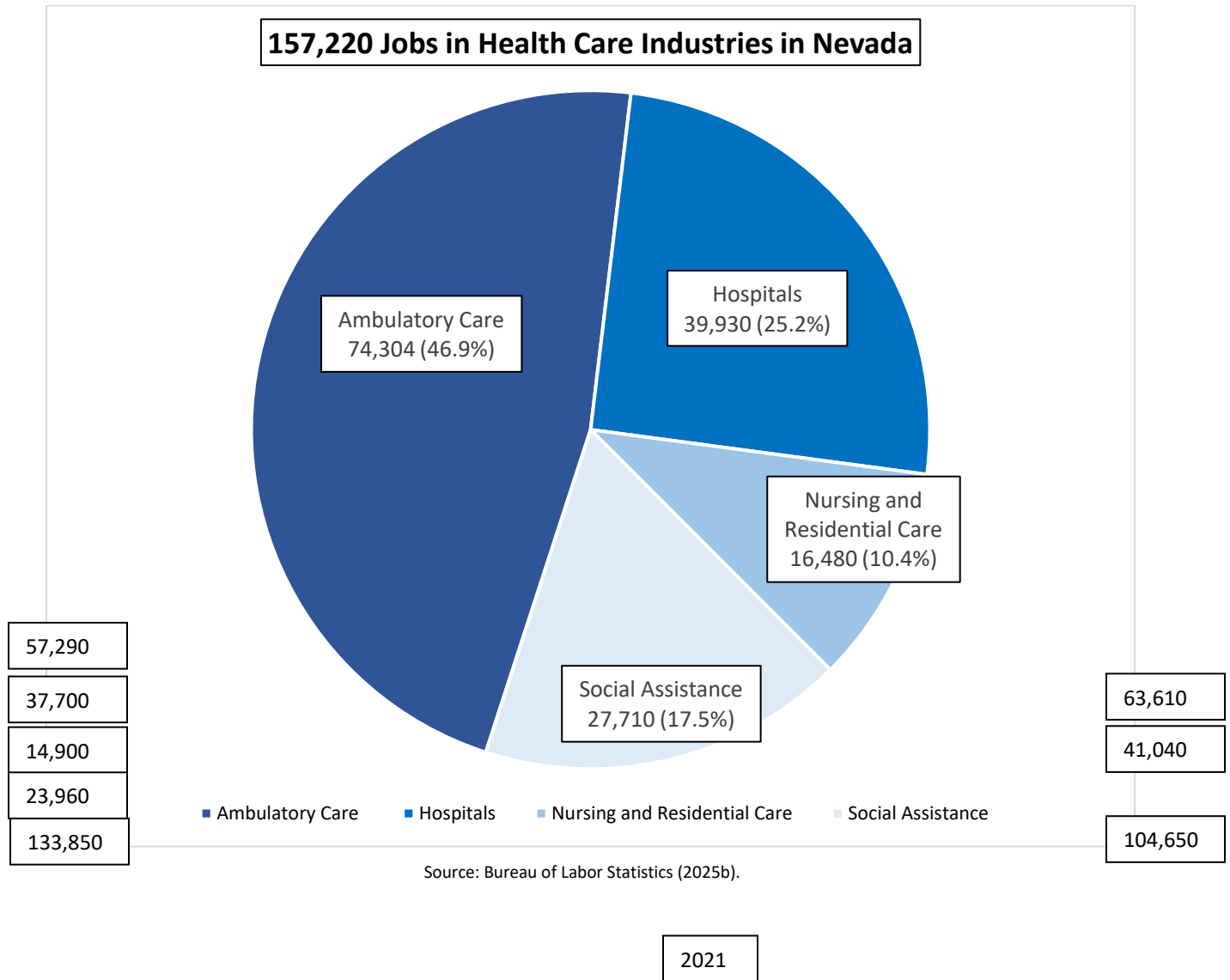


Figure 3: Projected Employment in the Health Care and Social Assistance Sector in Nevada – 2025 to 2035

- Over the next decade, employment in the health care sector in Nevada is projected to increase by 25,248 jobs (15.8%) – a rate that exceeds the projected employment growth for the entire economy (6.9%) (Figure 3, page 9).
- Based on current rates of health care employment per capita in Nevada and the United States, Nevada would need an additional 10,992 jobs in ambulatory care (Figure 5), an additional 10,660 jobs in hospitals (Figure 6), and an additional 8,273 jobs in nursing and residential care (Figure 7) to meet the national average (pages 10-11).
- Similarly, based on current rates of health care employment per capita in Nevada and the United States, Nevada would need an additional 4,865 registered nurses, an additional 2,303 physicians, and an additional 906 pharmacists to meet the national average (Figure 9, pages 12-13).
- Health workforce shortages are not limited to occupations requiring advanced education and training. Based on current rates of health care employment per capita in Nevada and the United States, Nevada would need an additional 23,327 home health and personal care aides, an additional 5,092 nursing assistants, and an additional 1,157 medical secretaries and administrative assistants to meet the national average (Figure 9, pages 12-13).

Highlights and key findings from Section 2 in the *Health Workforce in Nevada – 2025* report include:

- Over the past decade, a number of health care occupations have experienced substantial growth in both the number of licensees and the rate of licensees per 100,000 population. Noteworthy examples include advanced practitioners of nursing (Figures 10-13, pages 16-17), licensed clinical social workers (Figures 42-45, pages 32-33), and physician assistants (Figures 70-73, pages 46-47).

- Conversely, over the past decade, several health care occupations have experienced modest growth in the number of licensees and relatively flat growth in the rate of licensees per 100,000 population. Examples include clinical psychologists (Figures 26-29, pages 24-25), dental hygienists (Figures 30-33, pages 26-27), and respiratory therapists (Figures 86-89, pages 54-55).
- In general, the population per licensed health care worker is considerably higher in rural and frontier counties of Nevada versus urban areas of the state. For example, there are 24,301 residents per 1 clinical psychologist in rural and frontier counties as compared to 2,990 residents per 1 clinical psychologist in Washoe County (Figures 94-95, pages 58-59).

Highlights and key findings from Section 3 in the *Health Workforce in Nevada – 2025* report include:

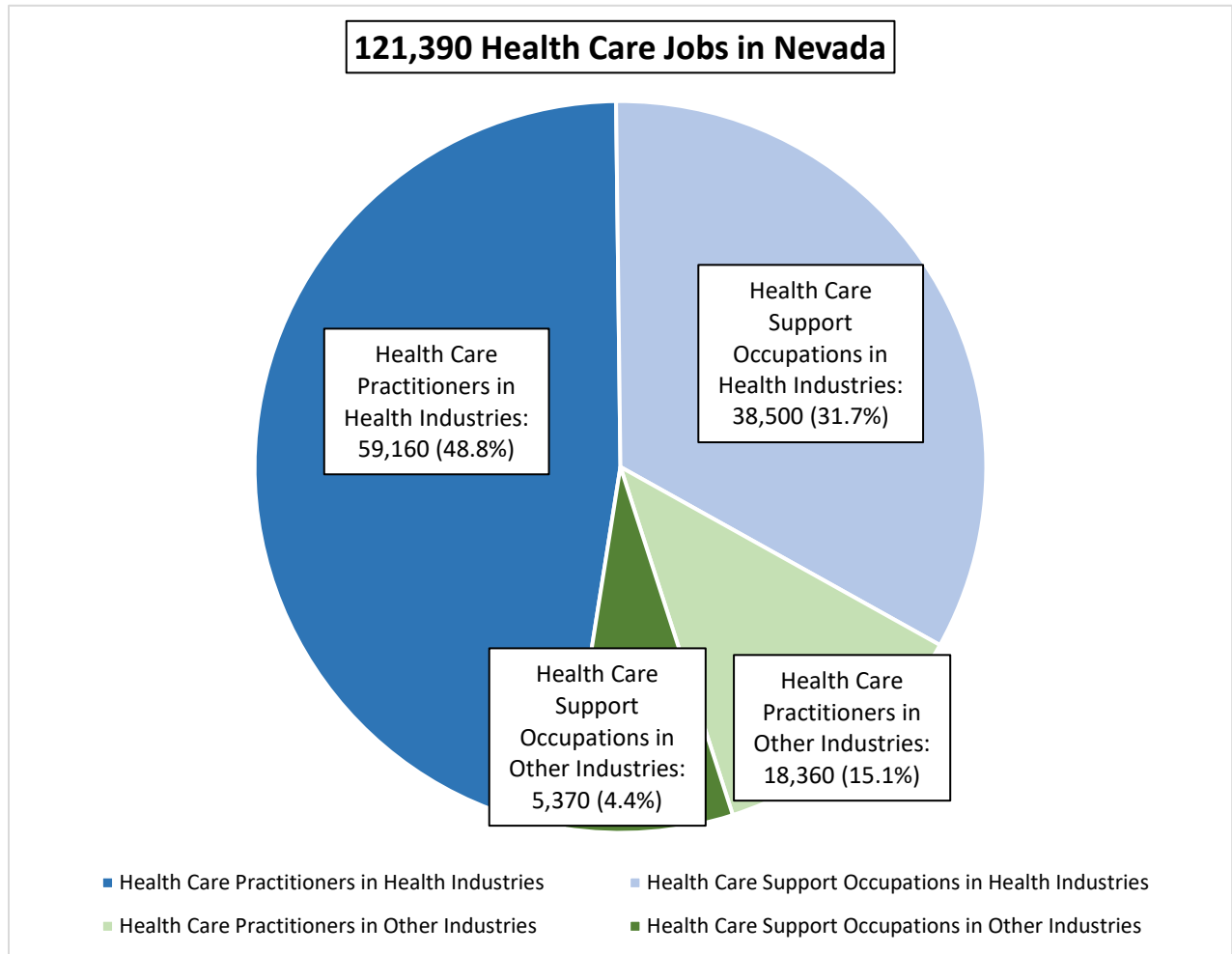
- The maps contained in Figures 96 through 104 highlight the current geographic distribution and severity of primary care, dental, and mental health professional shortage areas (HPSA) in Nevada, Clark County, and northern Nevada – shortages impacting both rural and urban areas of the state (pages 63-71).
- An estimated 2.2 million Nevadans or 64.9% of the state’s population currently reside in a federally designated primary care HPSA. Twelve of 17 counties in Nevada are single-county primary care HPSAs including 12 of the state’s 14 rural and frontier counties (Figure 105, page 72).
- Currently, nearly two million Nevadans or 58.2% of the state’s population currently reside in a federally designated dental HPSA. Thirteen of 17 counties in Nevada are single-county dental HPSAs including 12 of the state’s 14 rural and frontier counties (Figure 105, page 72).
- An estimated 3.1 million Nevadans or 91.3% of the state’s population reside in a federally designated mental health HPSA – 15 of 17 counties in Nevada are single-county mental health HPSAs. One hundred percent of the state’s 302,794 rural and frontier residents live in a mental health HPSA (Figure 105, page 72).

Figure 2: Employment in the Health Care and Social Assistance Sector in Nevada – 2024

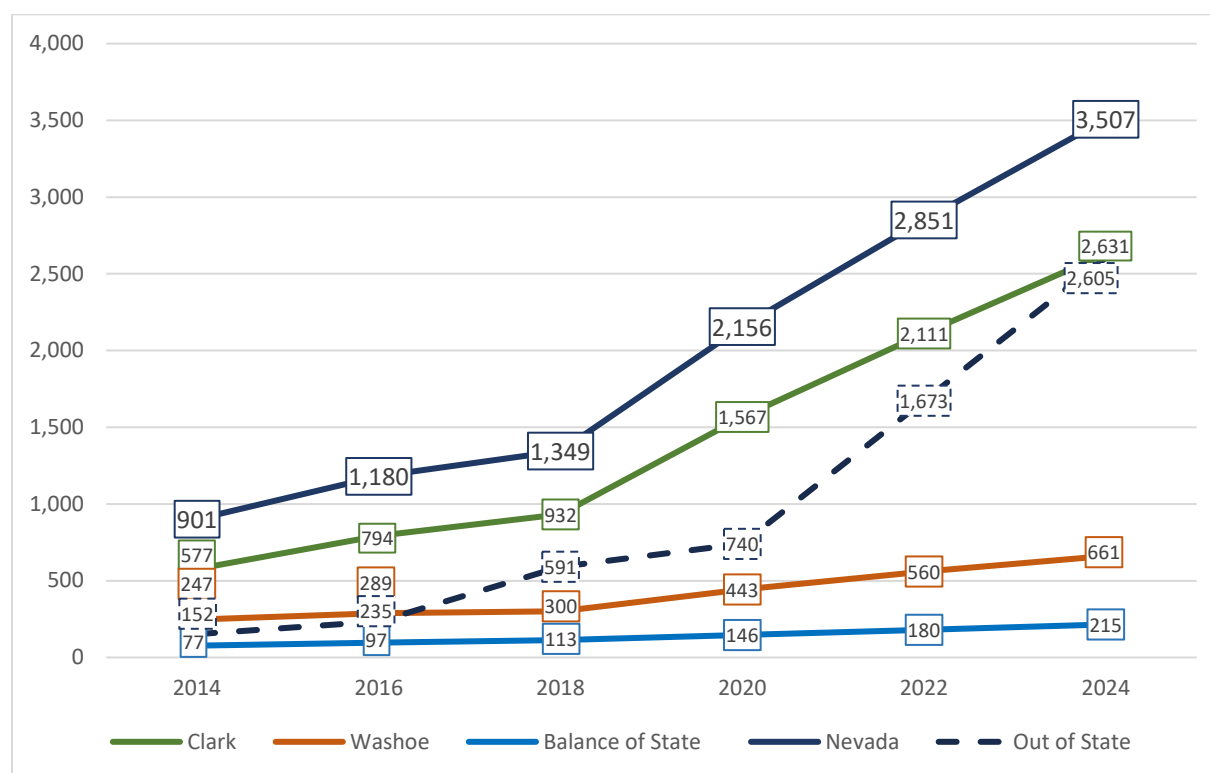

Figure 11: Advanced Practitioners of Nursing in Nevada – 2014 to 2024

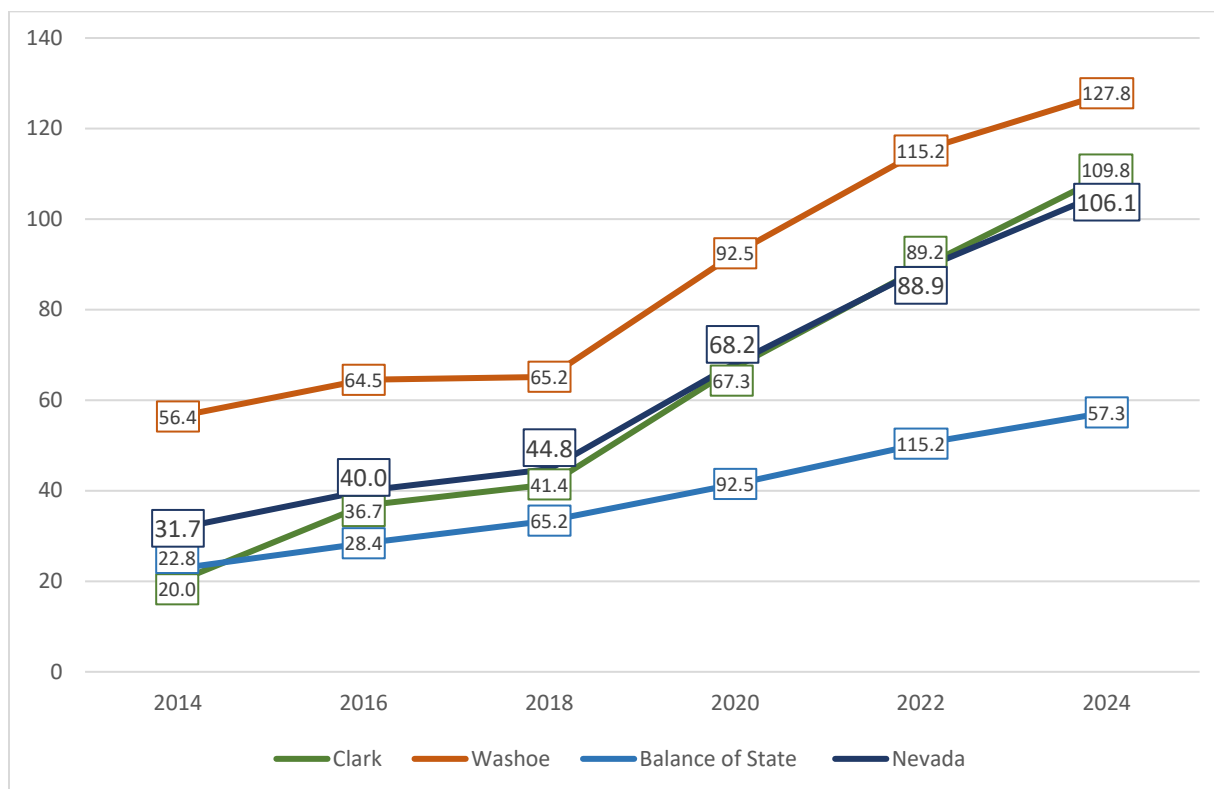

Figure 13: Advanced Practitioners of Nursing per 100,000 Population in Nevada – 2014 to 2024



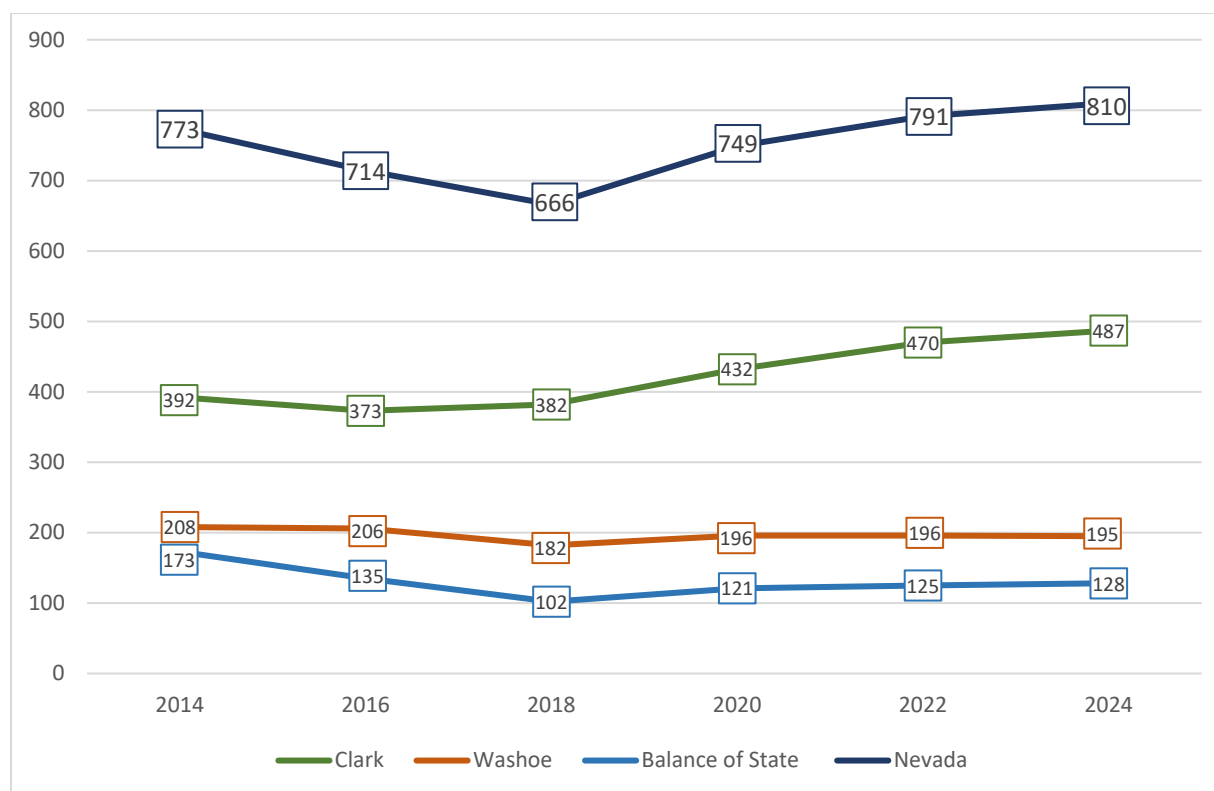

Figure 15: Alcohol and Drug Counselors in Nevada – 2014 to 2024



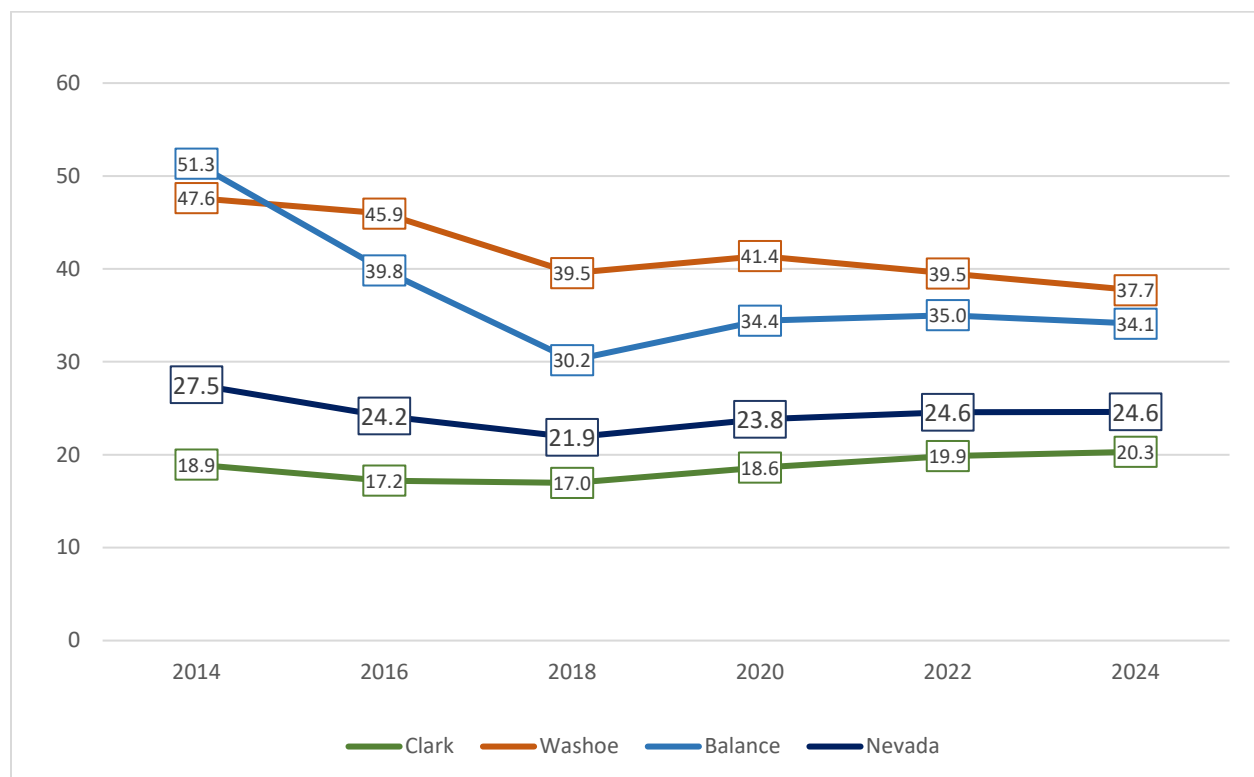

Figure 17: Alcohol and Drug Counselors per 100,000 Population in Nevada – 2014 to 2024



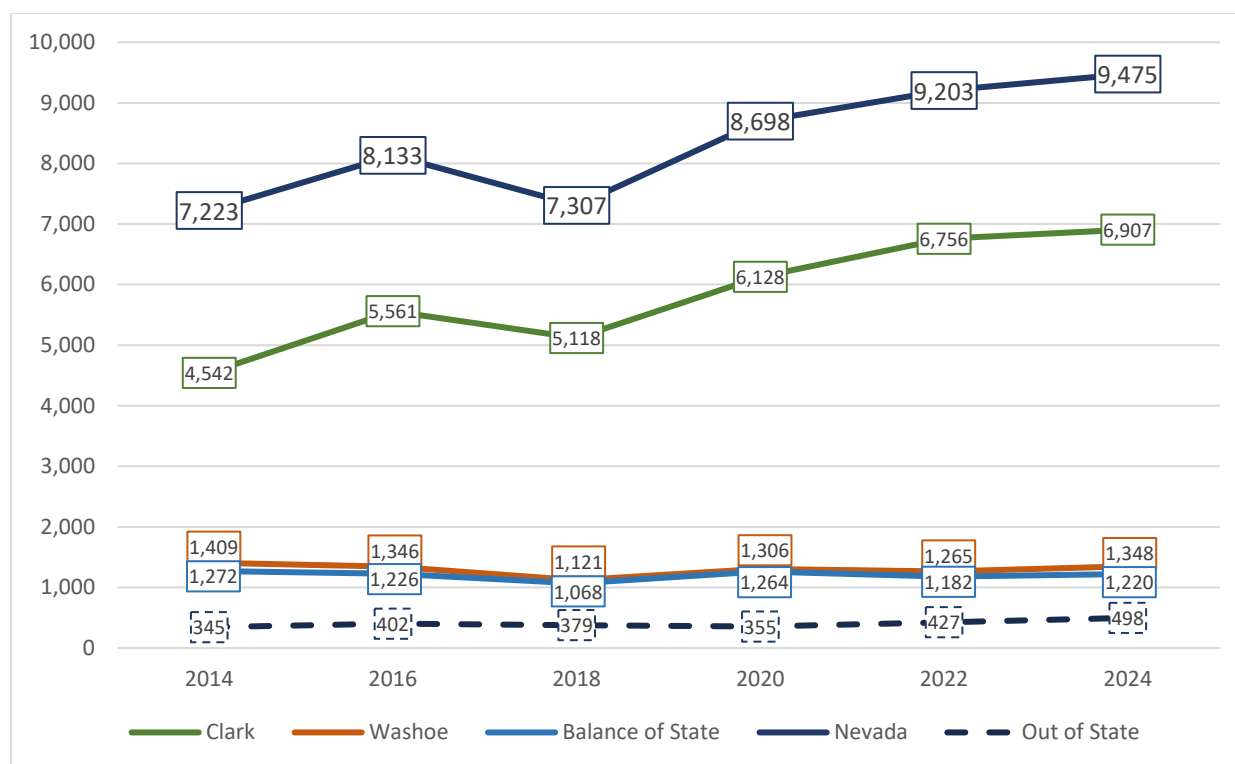

Figure 19: Certified Nurse Assistants in Nevada – 2014 to 2024



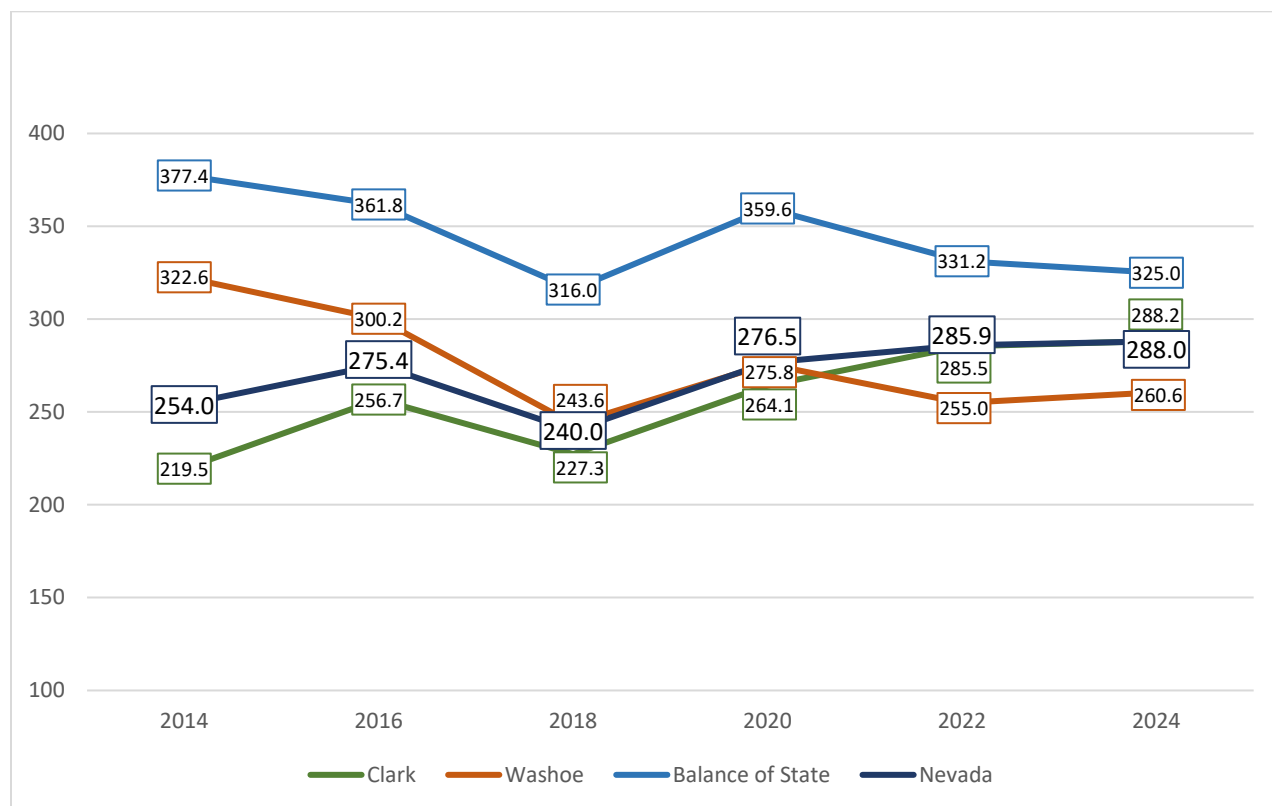

Figure 21: Certified Nurse Assistants per 100,000 Population in Nevada – 2014 to 2024



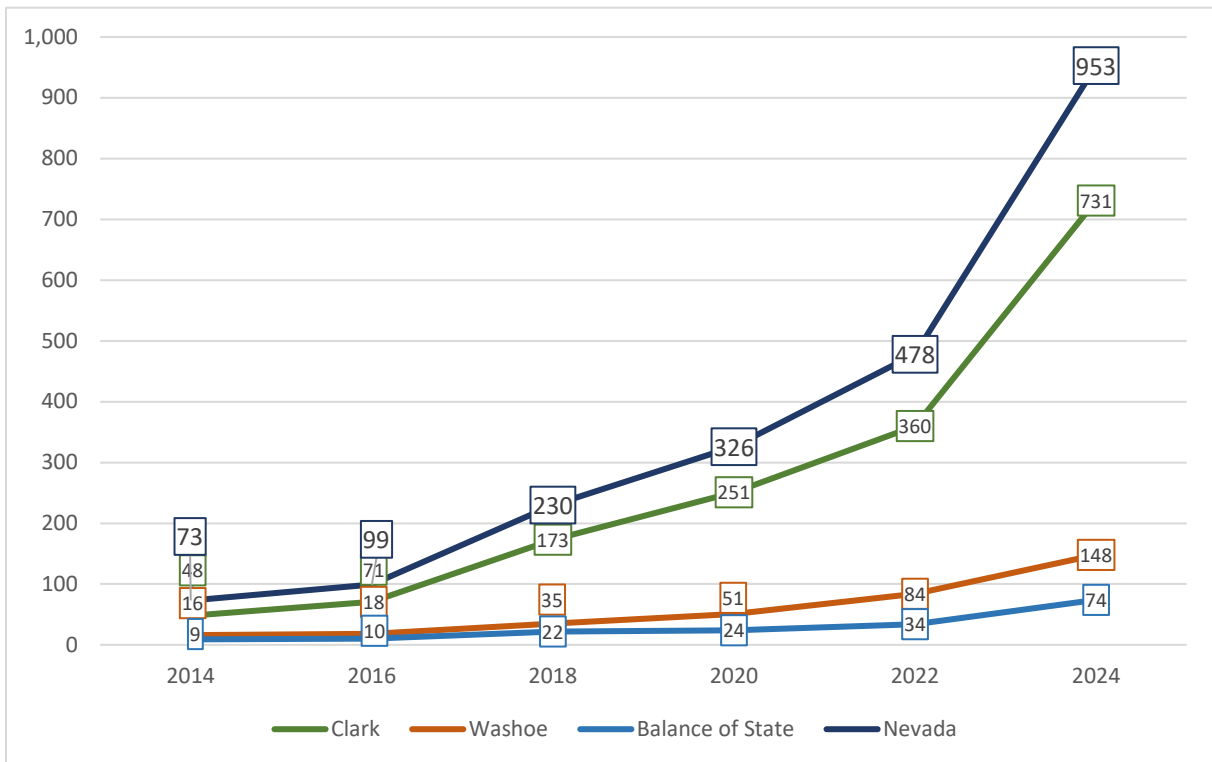

Figure 23: Clinical Professional Counselors in Nevada – 2014 to 2024



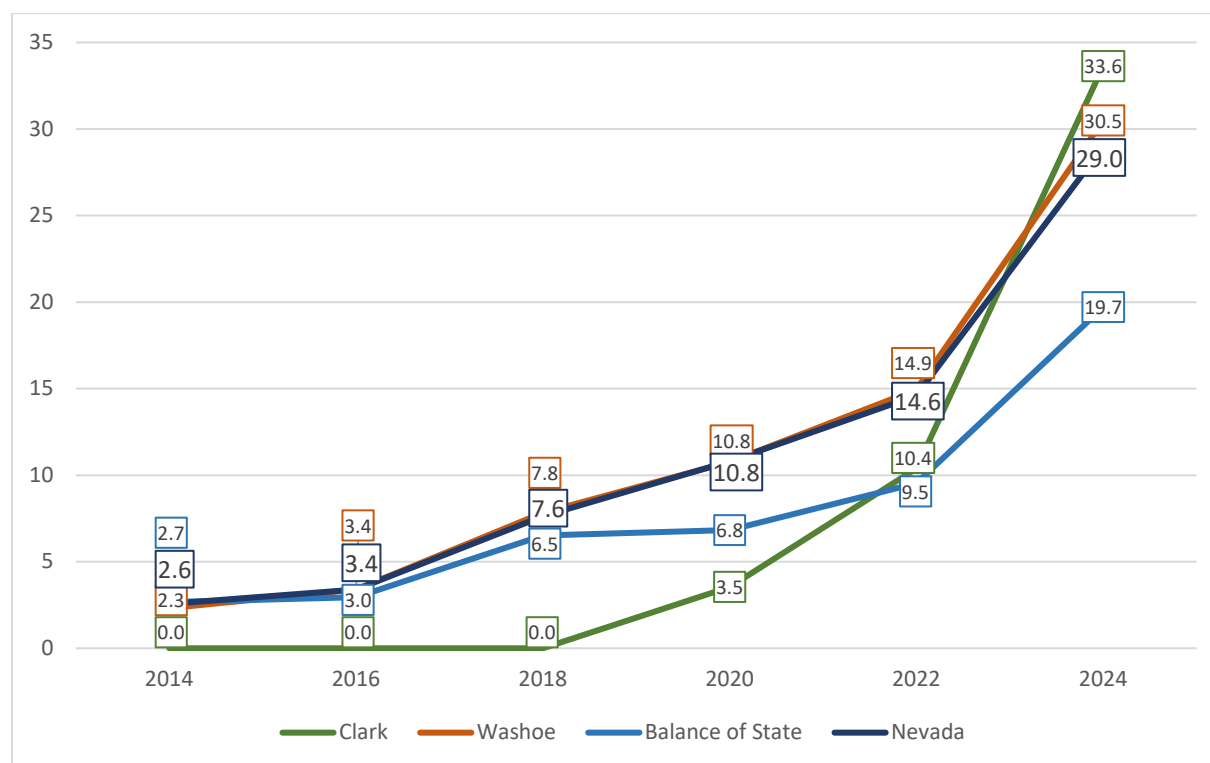

Figure 25: Clinical Professional Counselors per 100,000 Population in Nevada – 2014 to 2024



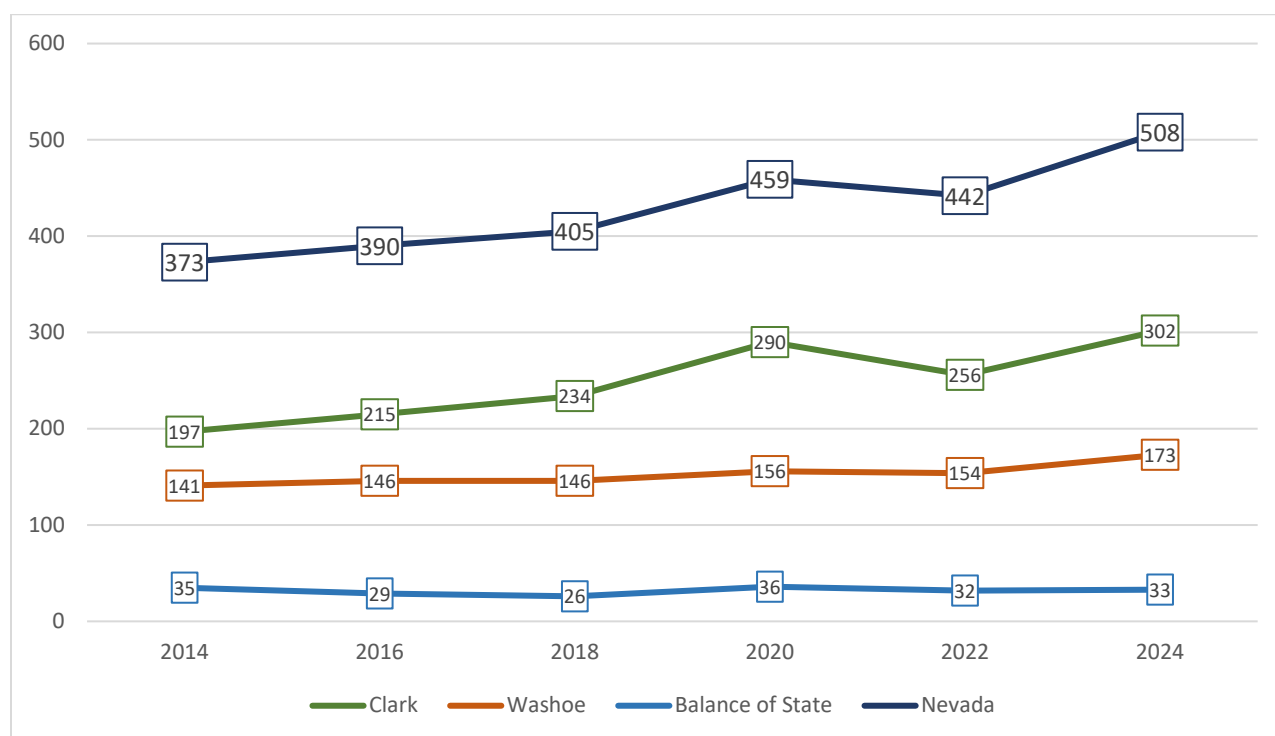

Figure 27: Clinical Psychologists in Nevada – 2014 to 2024



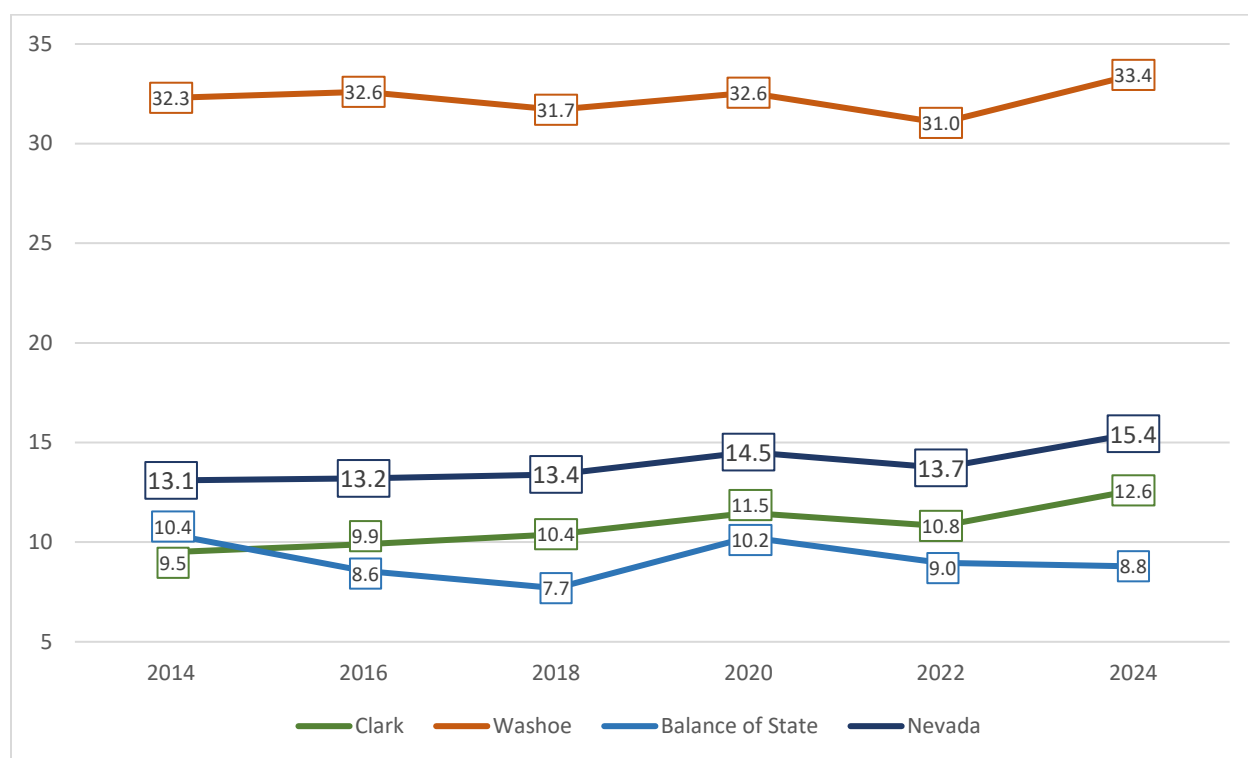

Figure 29: Clinical Psychologists per 100,000 Population in Nevada – 2014 to 2024



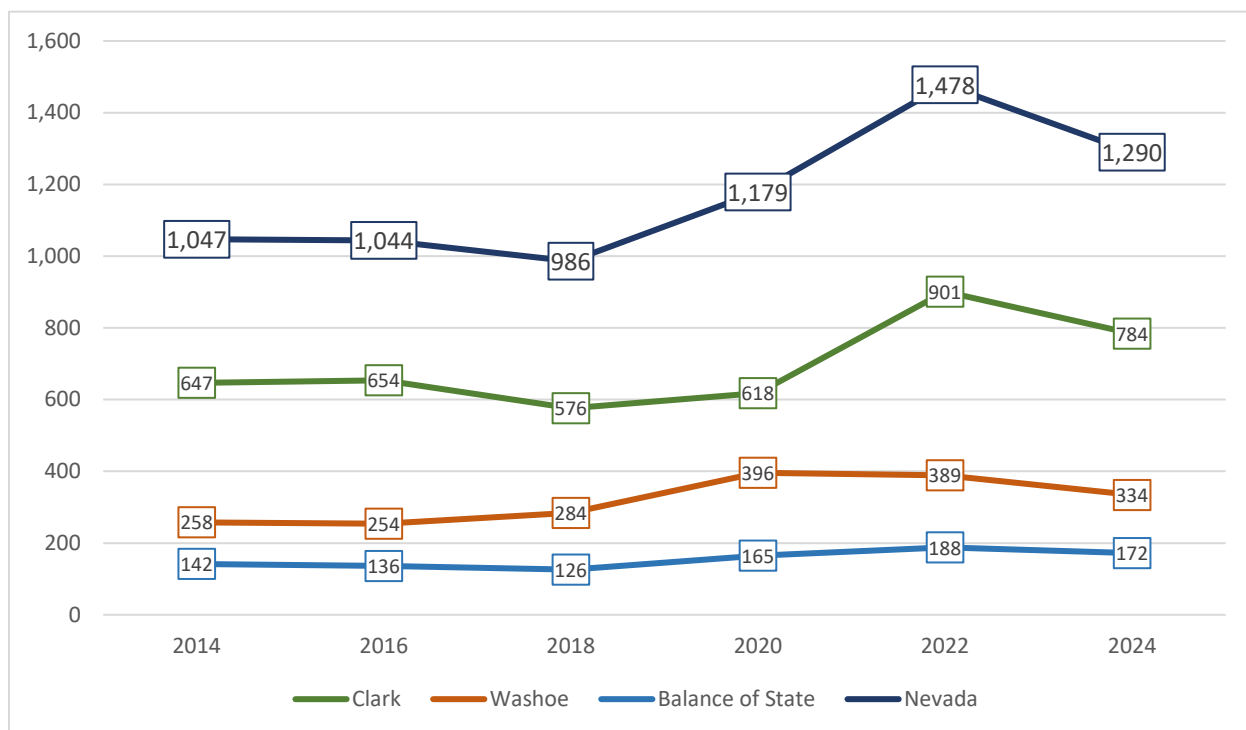

Figure 31: Registered Dental Hygienists in Nevada – 2014 to 2024



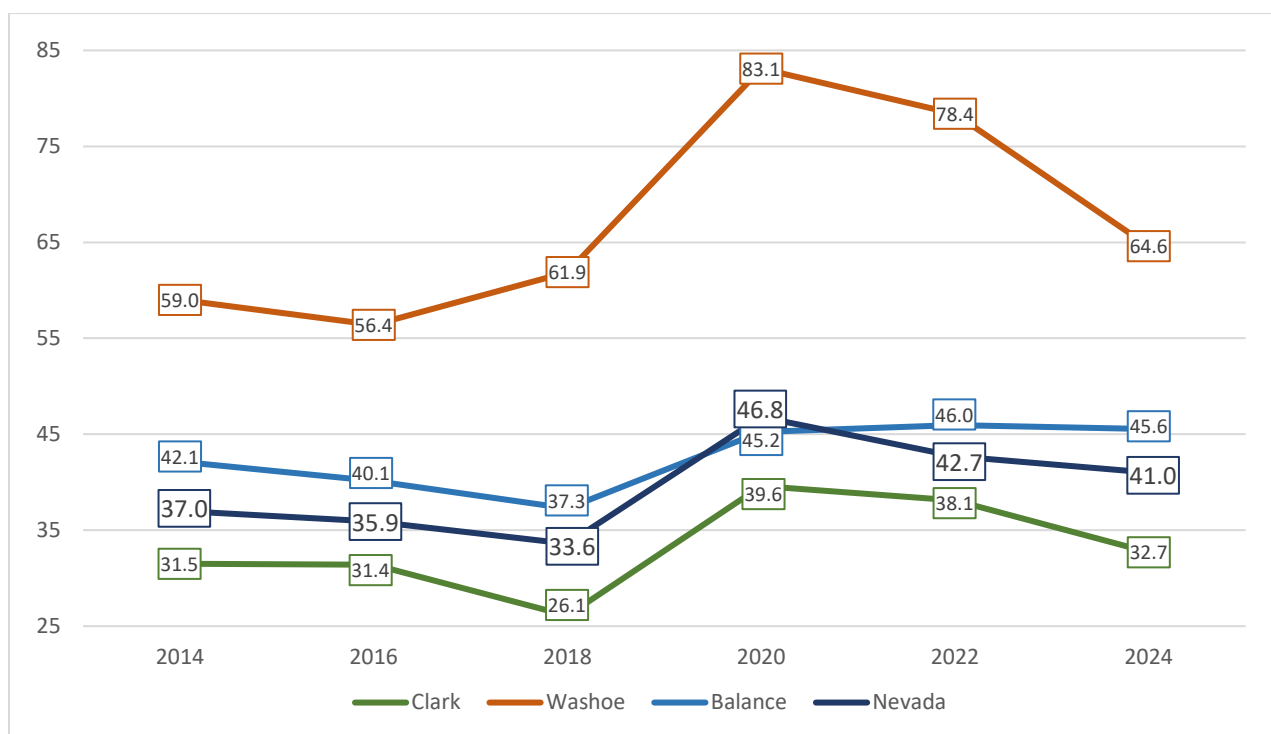

Figure 33: Registered Dental Hygienists per 100,000 Population in Nevada – 2014 to 2024



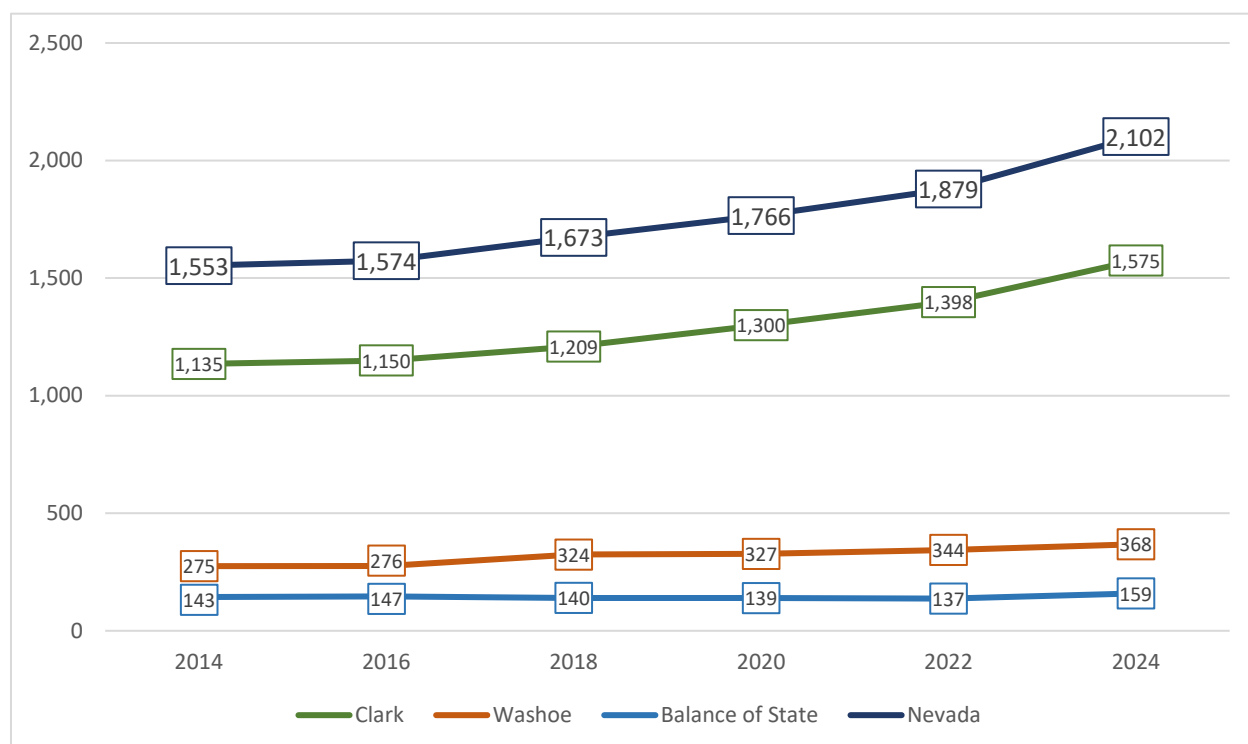

Figure 35: Dentists in Nevada – 2014 to 2024



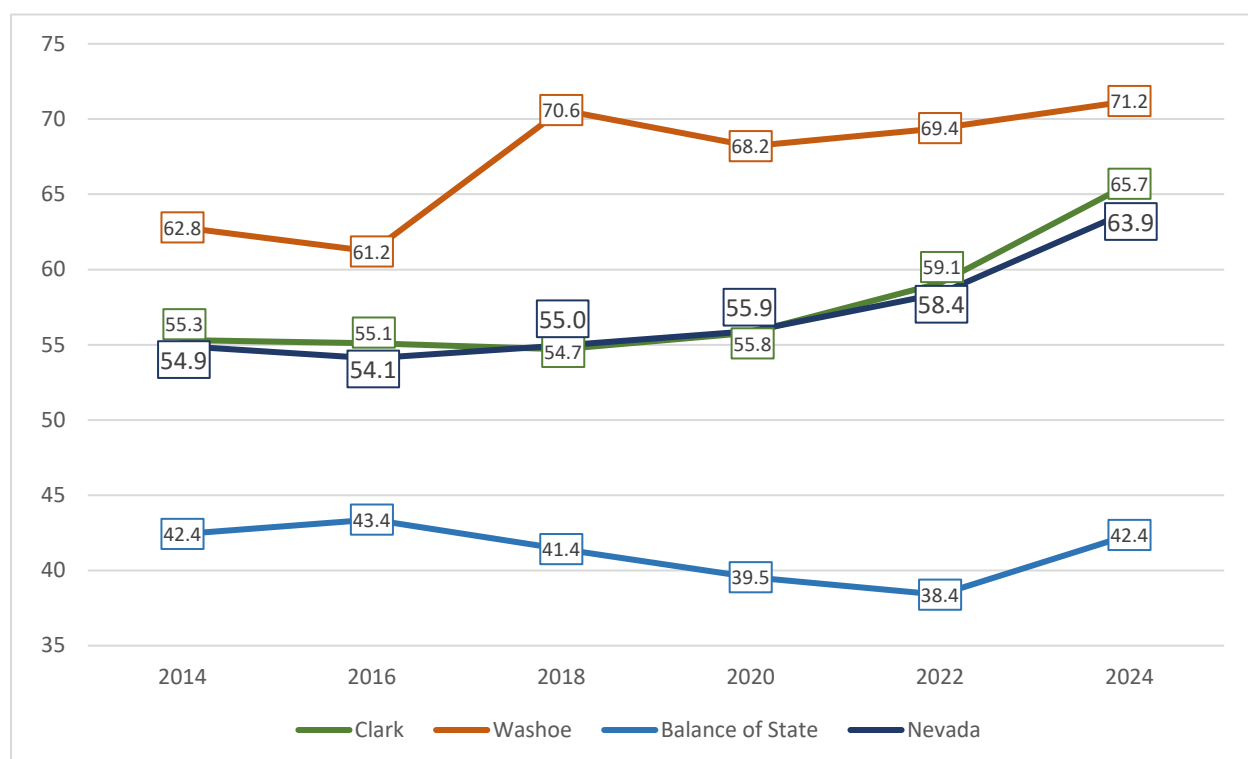

Figure 37: Dentists per 100,000 Population in Nevada – 2014 to 2024



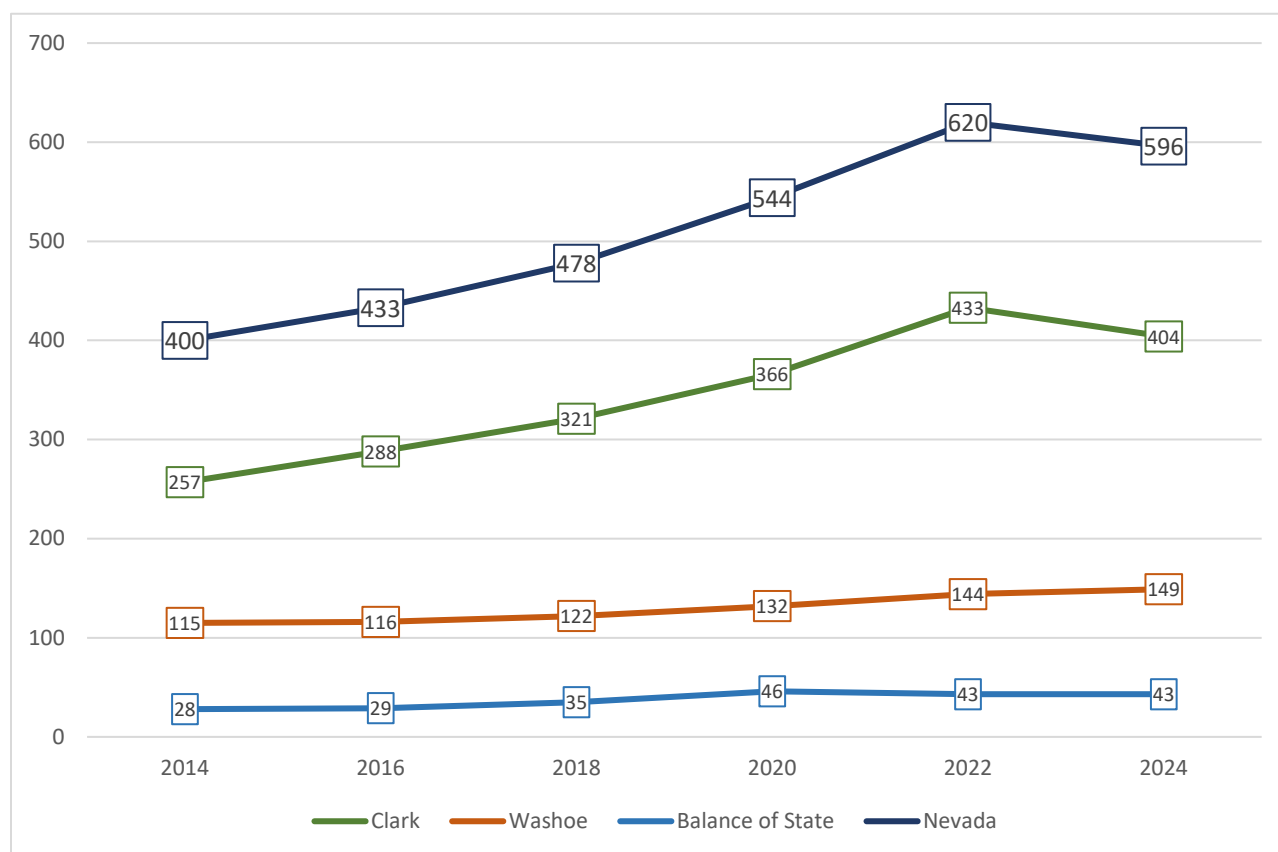

Figure 39: Registered Dietitians in Nevada – 2014 to 2024

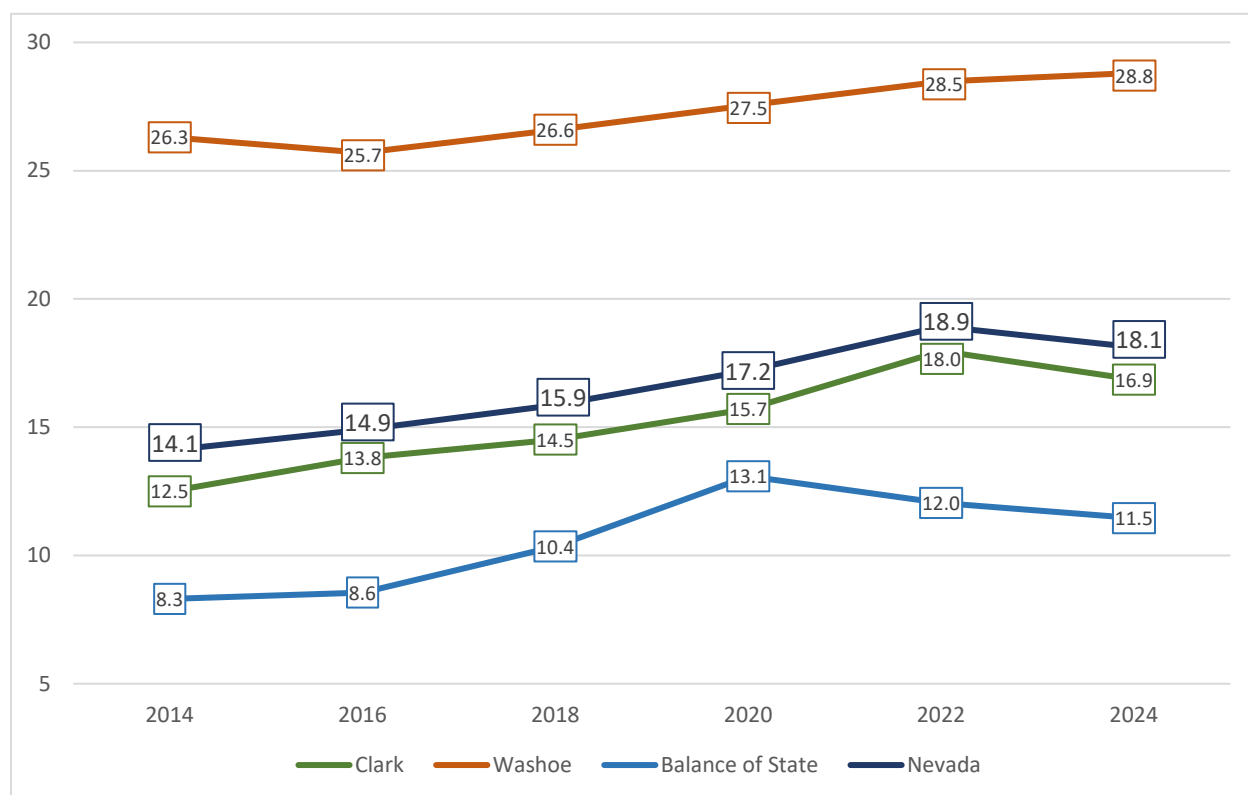

Figure 41: Registered Dietitians per 100,000 Population in Nevada – 2014 to 2024

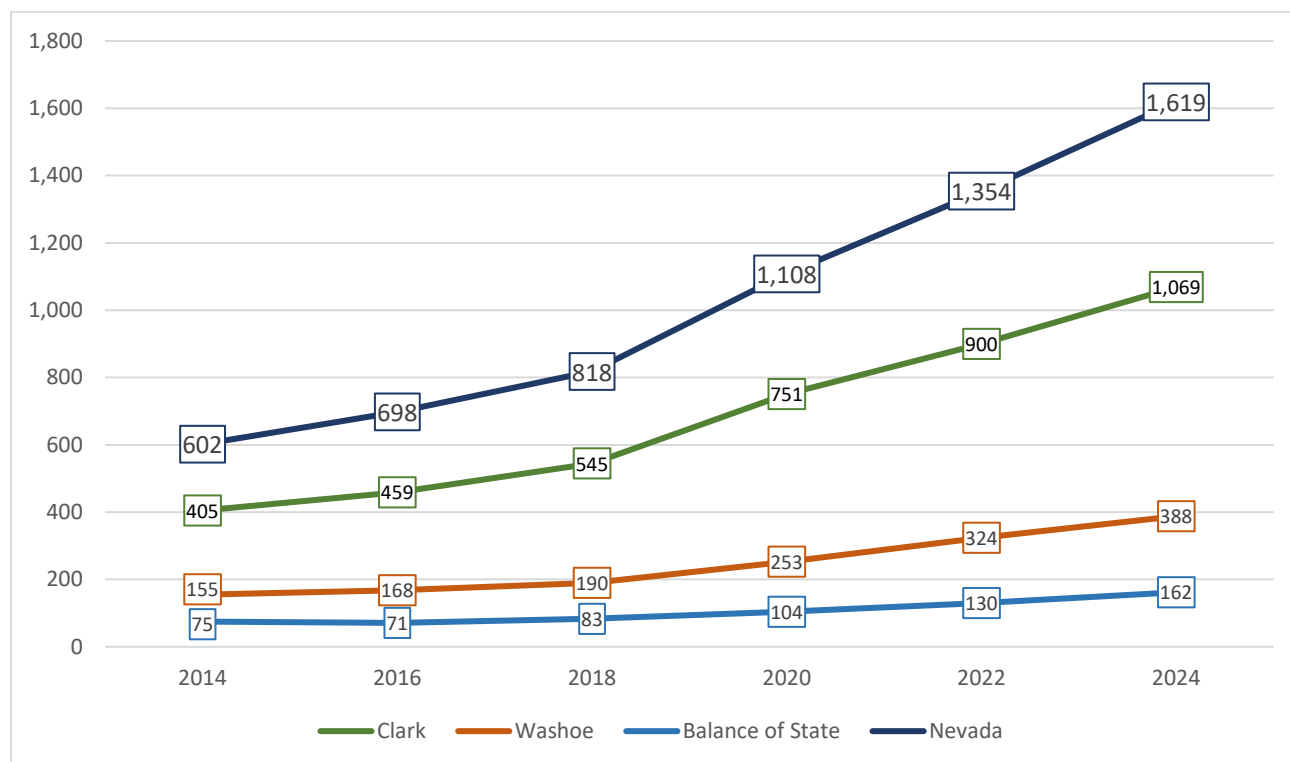

Figure 43: Licensed Clinical Social Workers in Nevada – 2014 to 2024



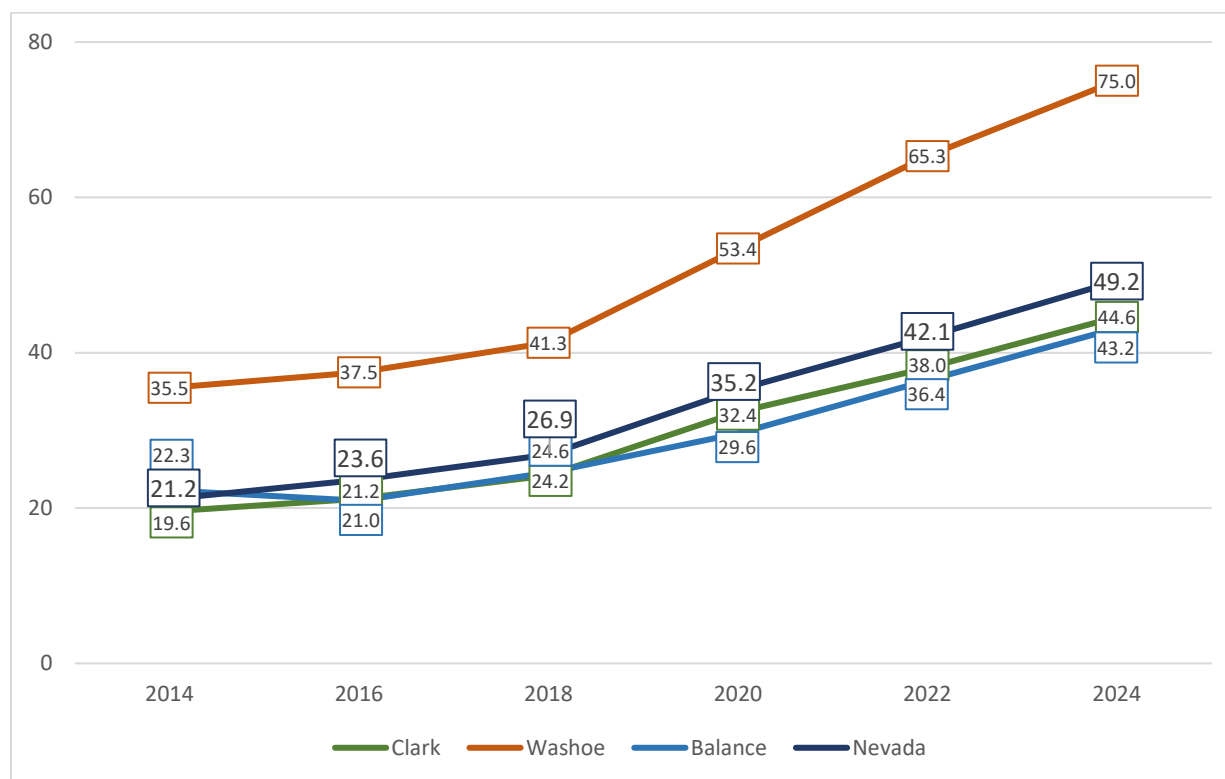

Figure 45: Licensed Clinical Social Workers per 100,000 Population in Nevada – 2014 to 2024



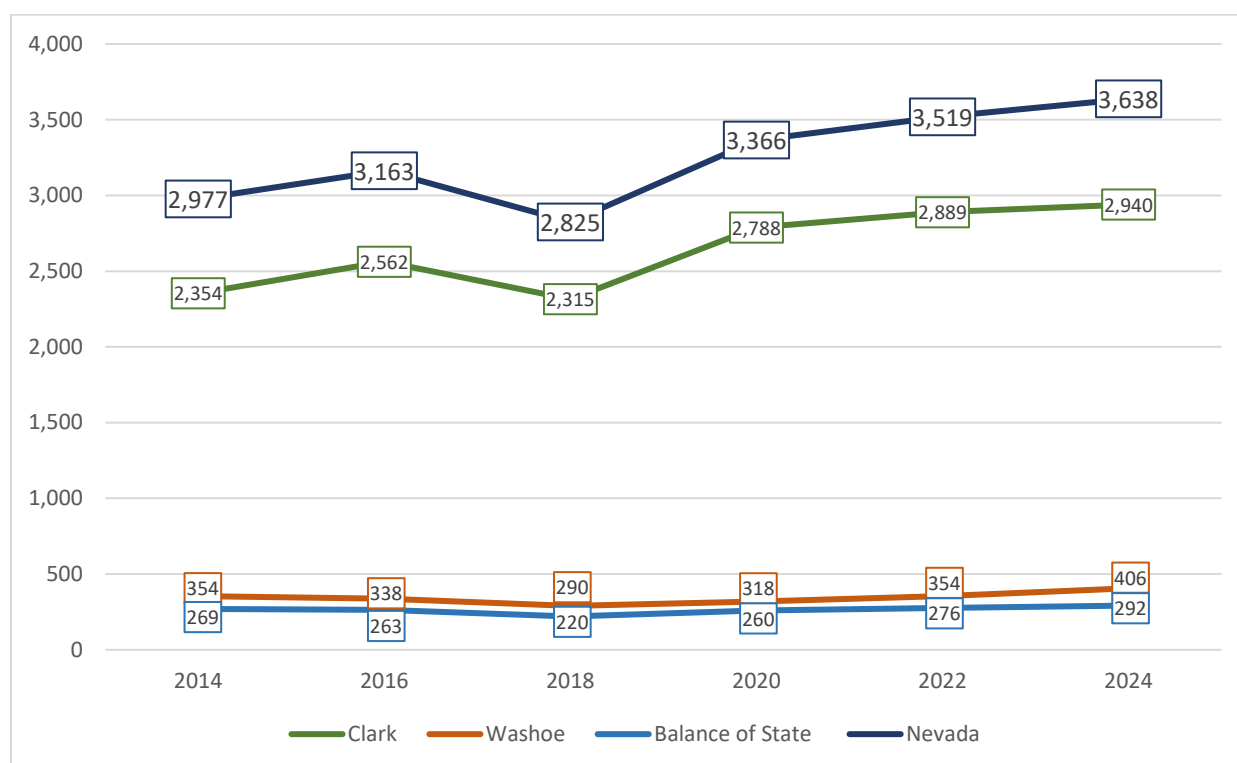

Figure 47: Licensed Practical Nurses in Nevada – 2014 to 2024



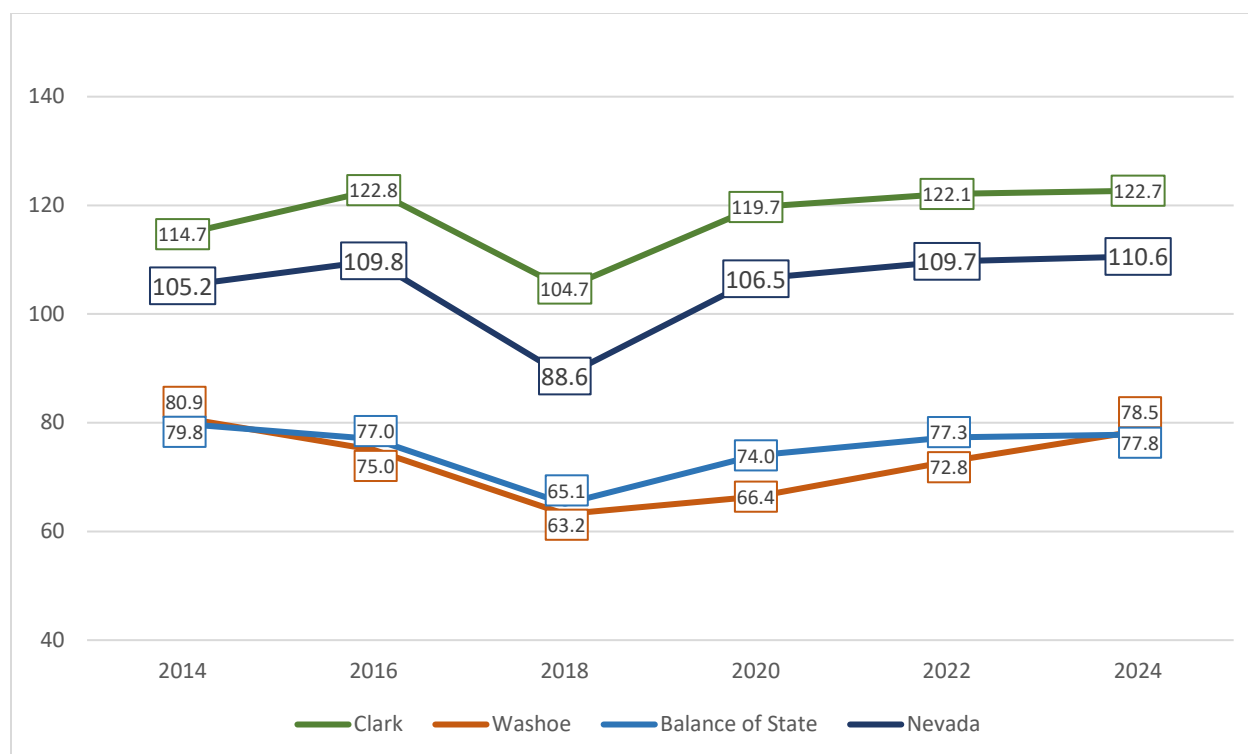

Figure 49: Licensed Practical Nurses per 100,000 Population in Nevada – 2014 to 2024



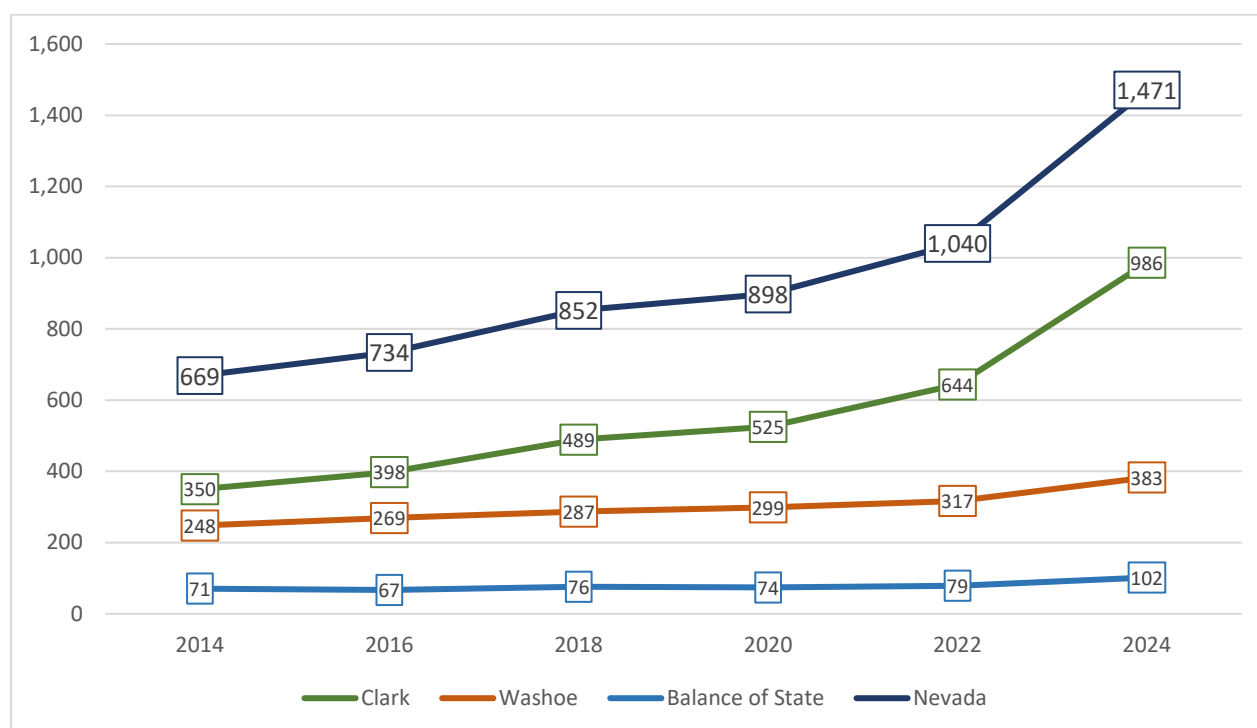

Figure 51: Marriage and Family Therapists in Nevada – 2014 to 2024



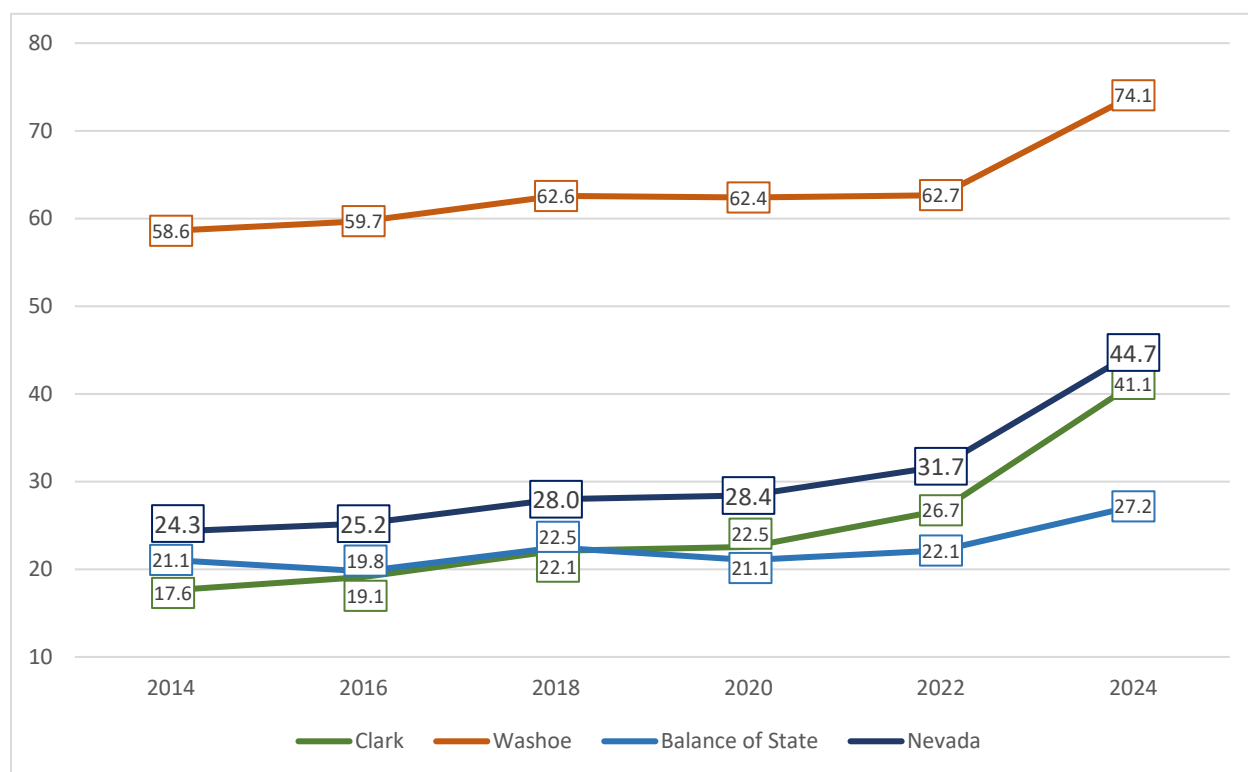

Figure 53: Marriage and Family Therapists per 100,000 Population in Nevada – 2014 to 2024



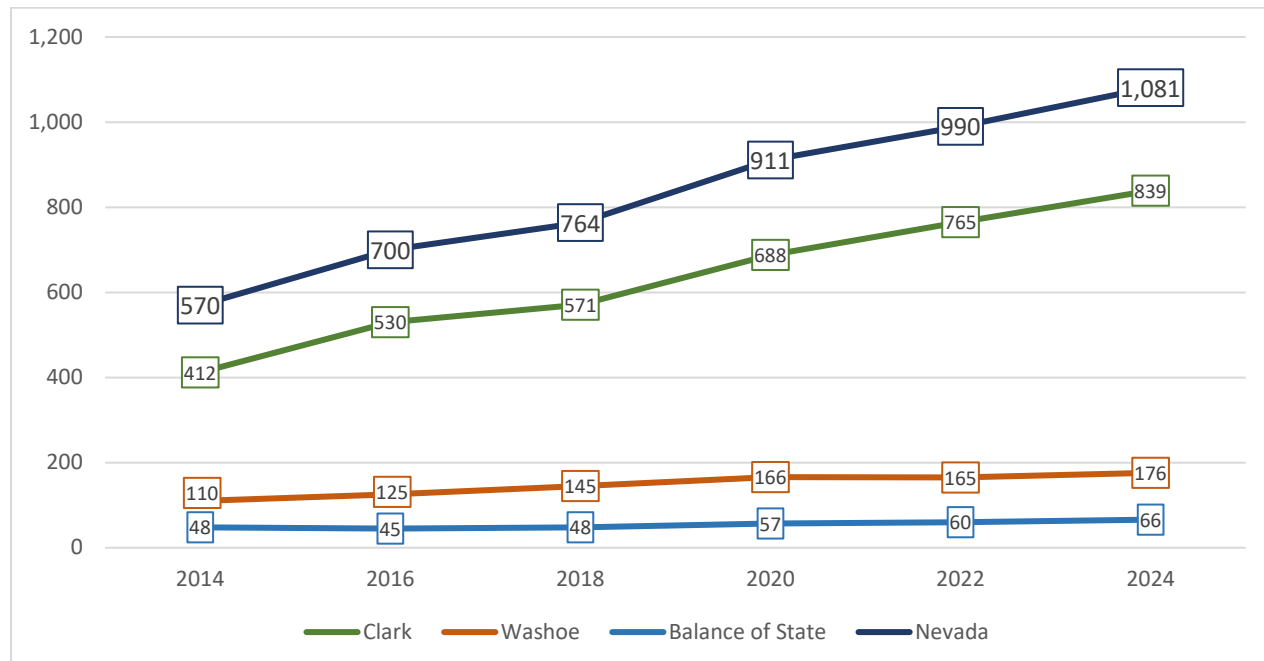

Figure 55: Occupational Therapists in Nevada – 2014 to 2024



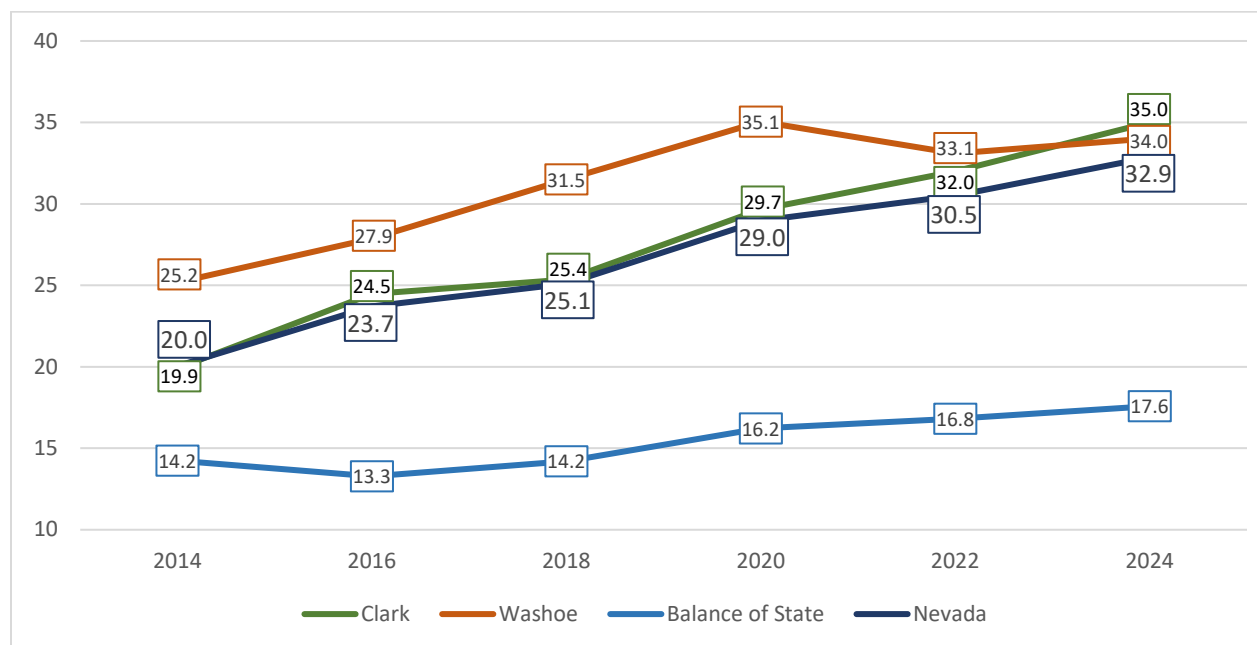

Figure 57: Occupational Therapists per 100,000 Population in Nevada – 2014 to 2024



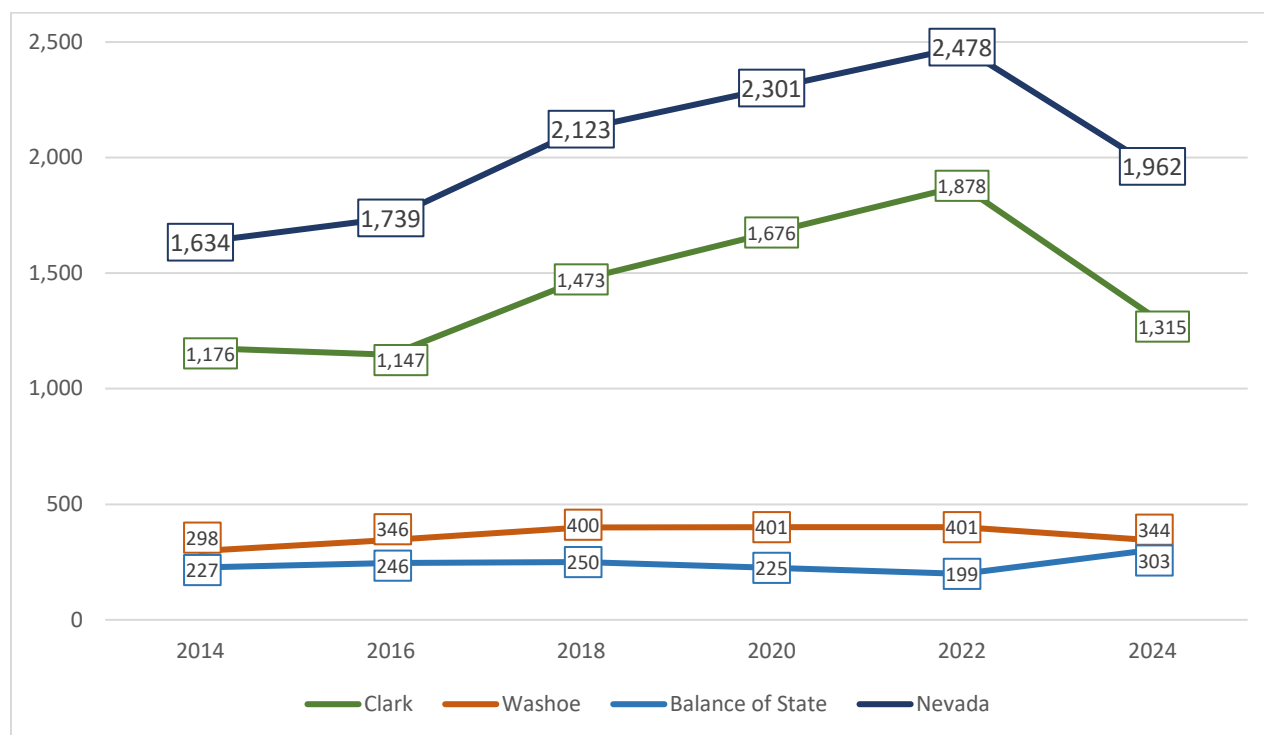

Figure 59: Paramedics in Nevada – 2014 to 2024



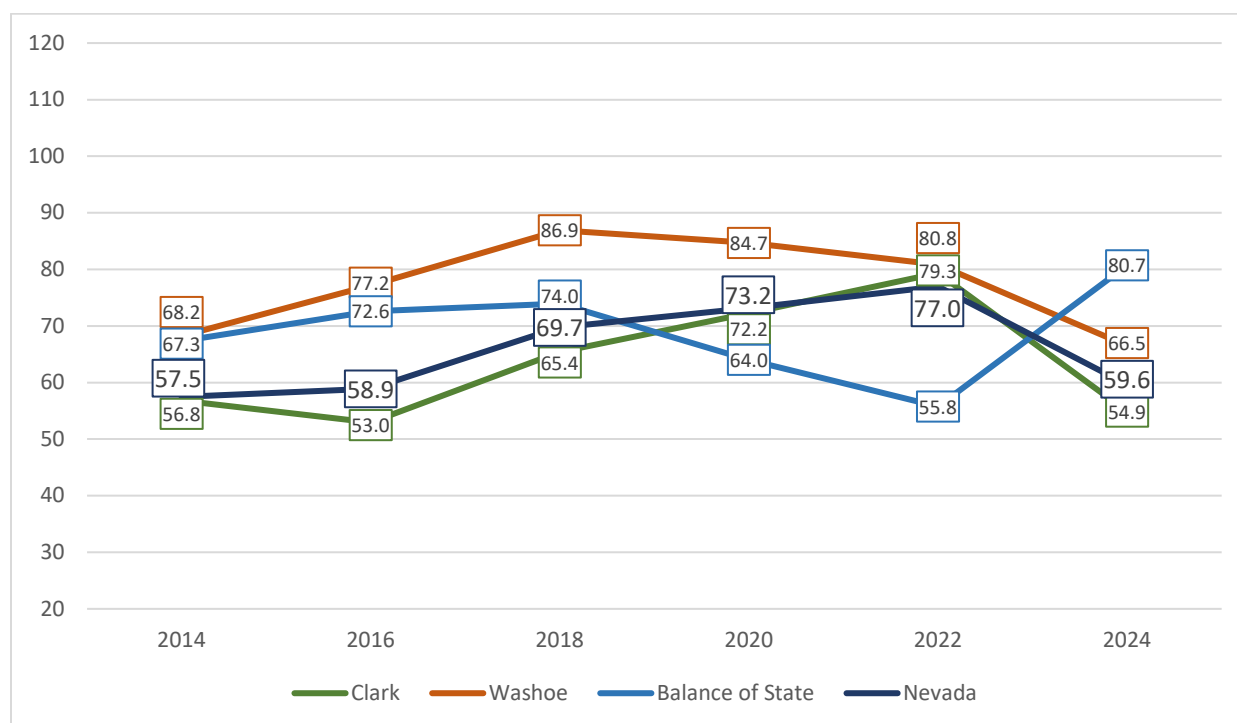

Figure 61: Paramedics per 100,000 Population in Nevada – 2014 to 2024



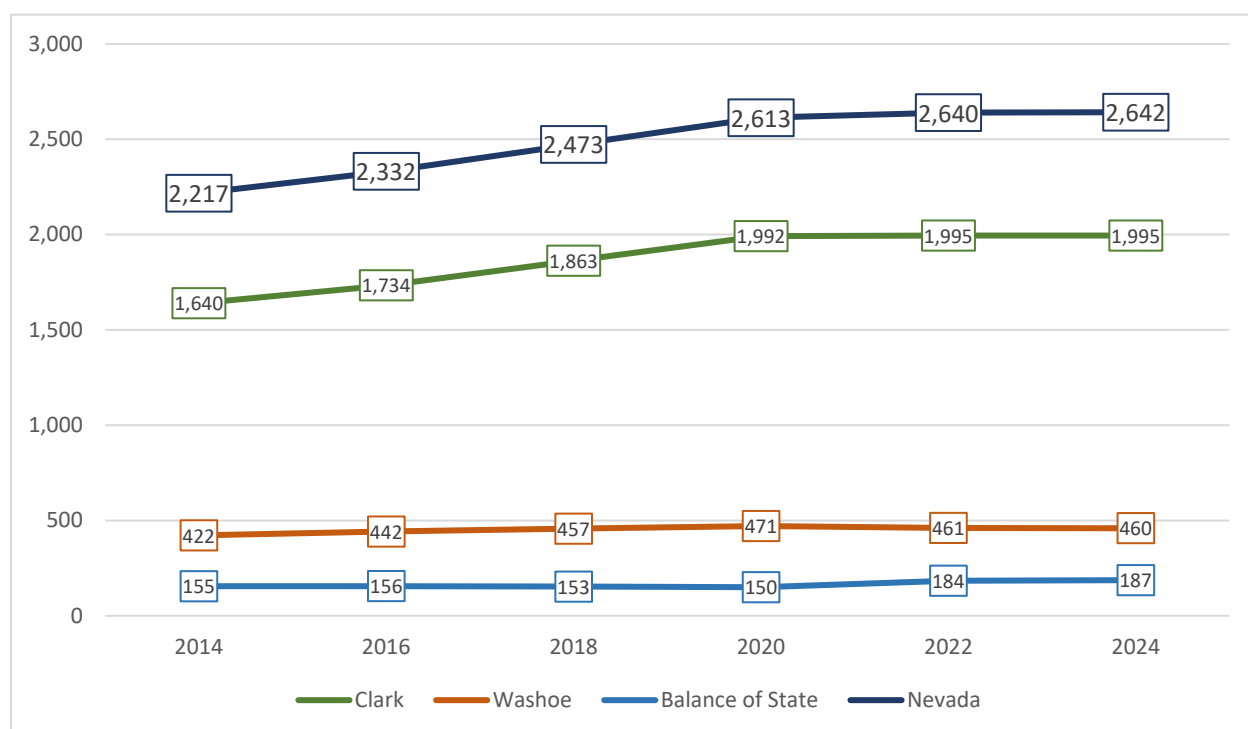

Figure 63: Pharmacists in Nevada – 2014 to 2024



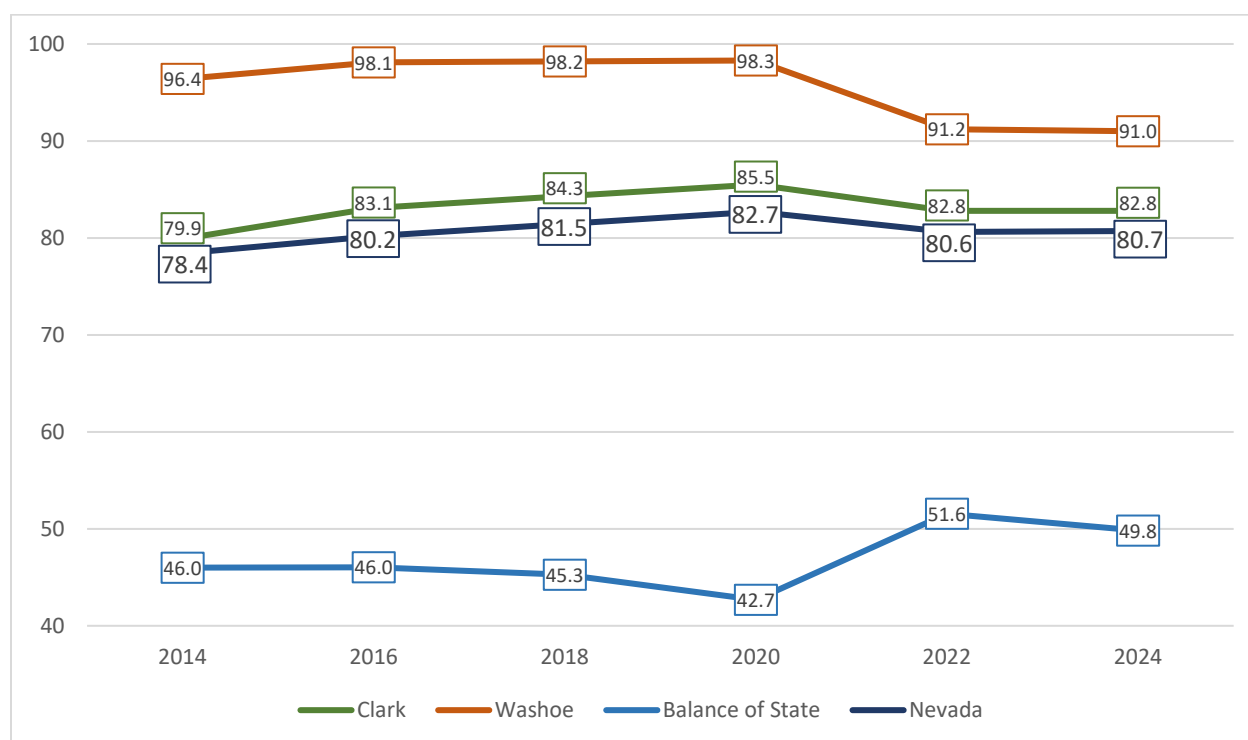

Figure 65: Pharmacists per 100,000 Population in Nevada – 2014 to 2024



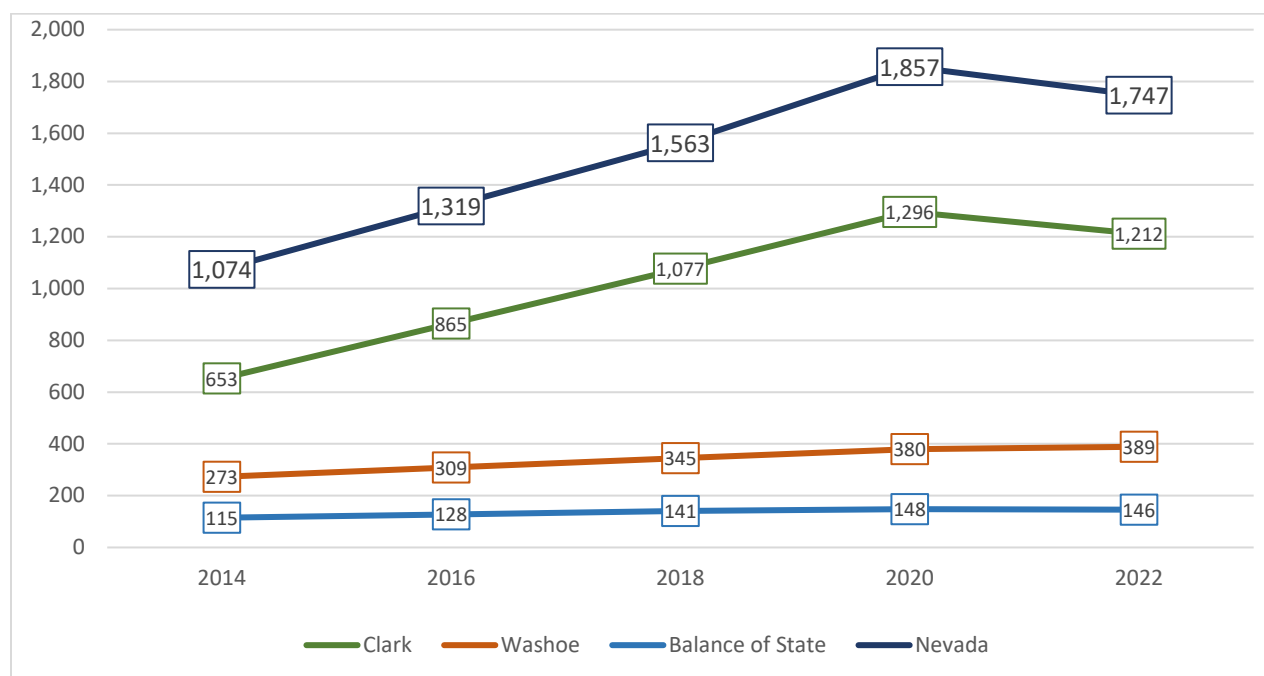

Figure 67: Physical Therapists in Nevada – 2014 to 2022



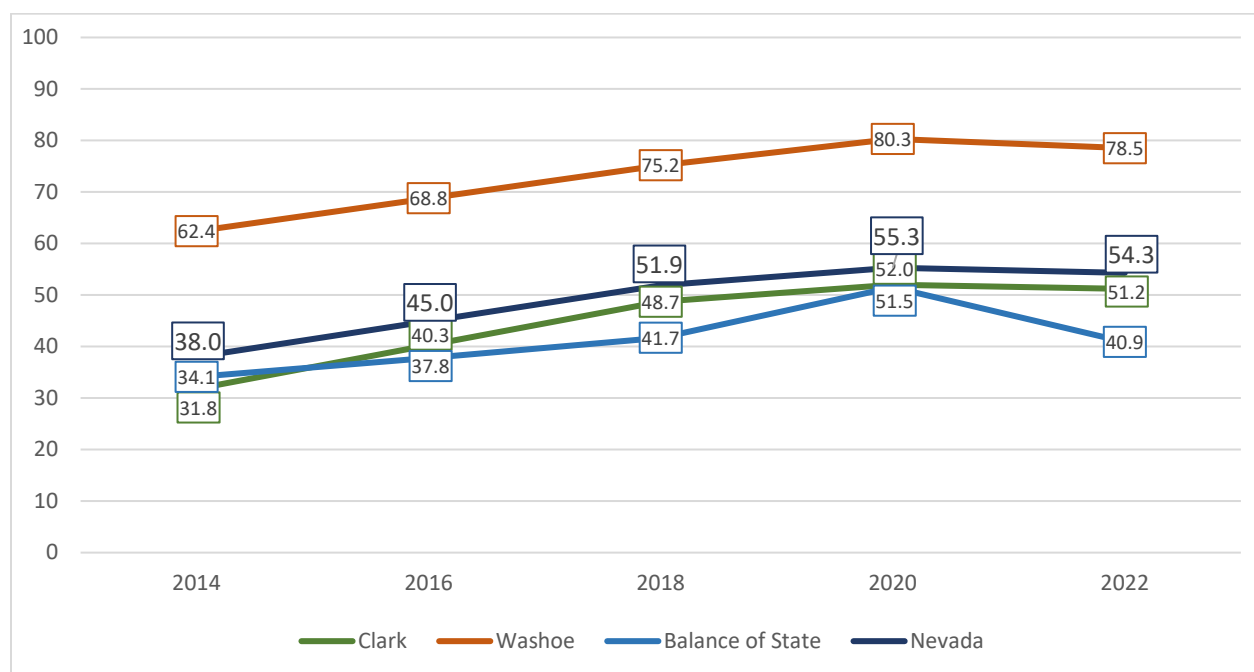

Figure 69: Physical Therapists per 100,000 Population in Nevada –2014 to 2022



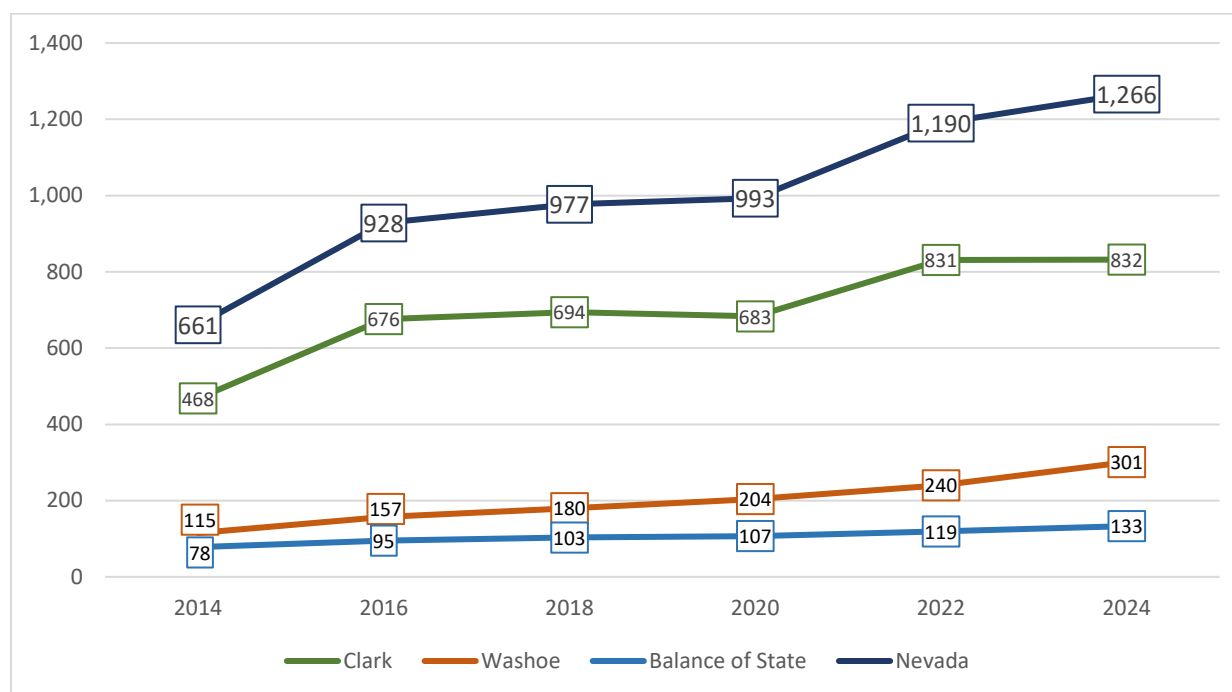

Figure 71: Physician Assistants in Nevada – 2014 to 2024



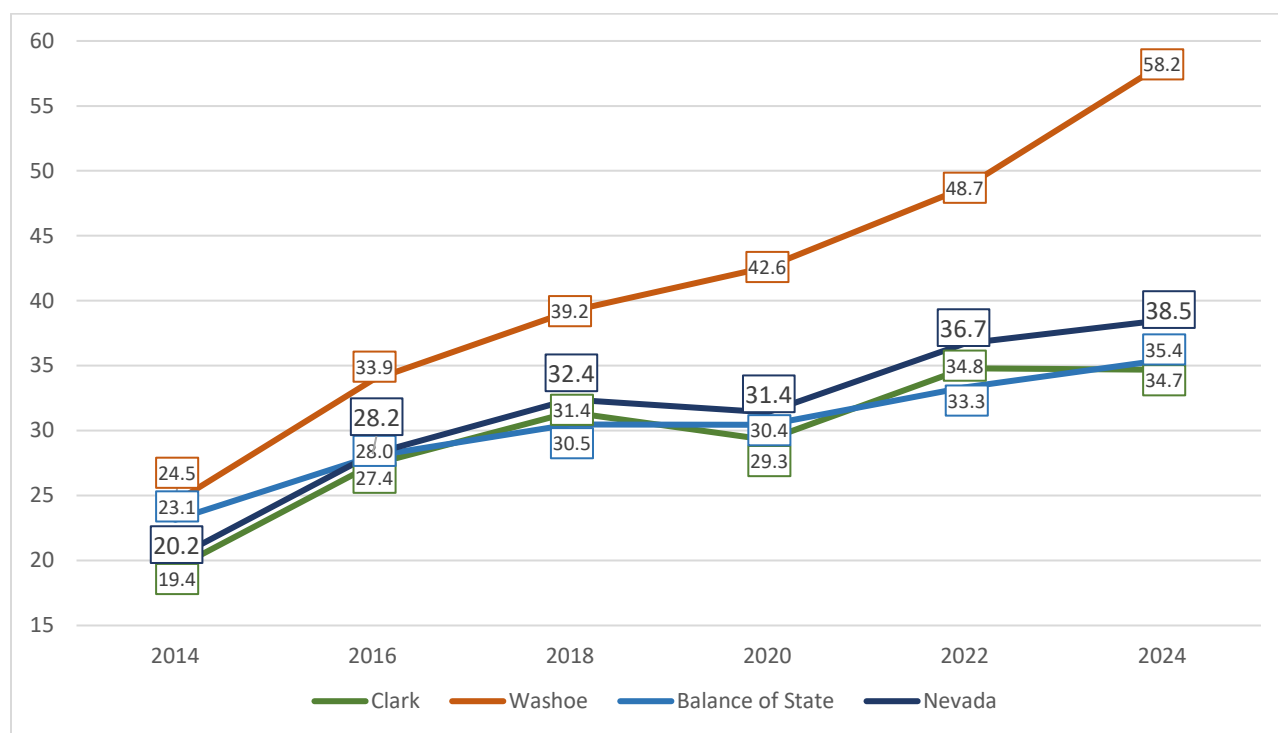

Figure 73: Physician Assistants per 100,000 Population in Nevada – 2014 to 2024

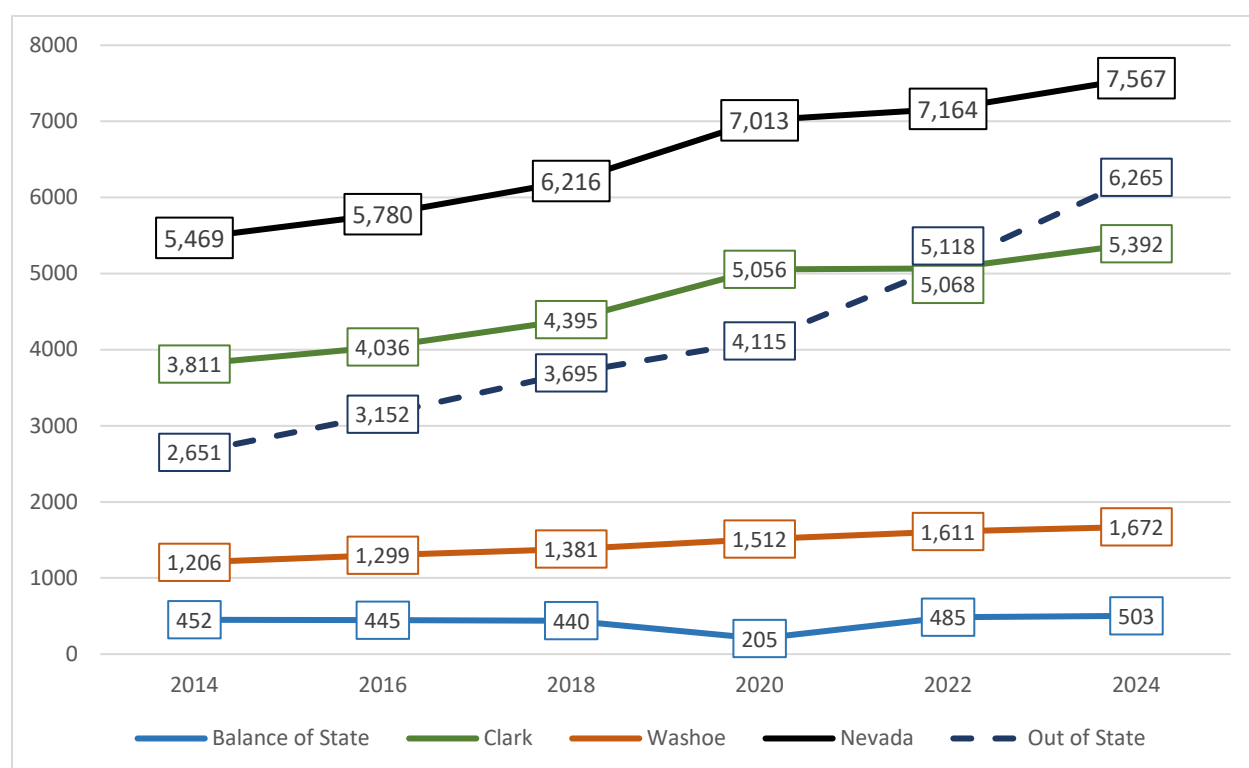

Figure 75: Physicians in Nevada – 2014 to 2024

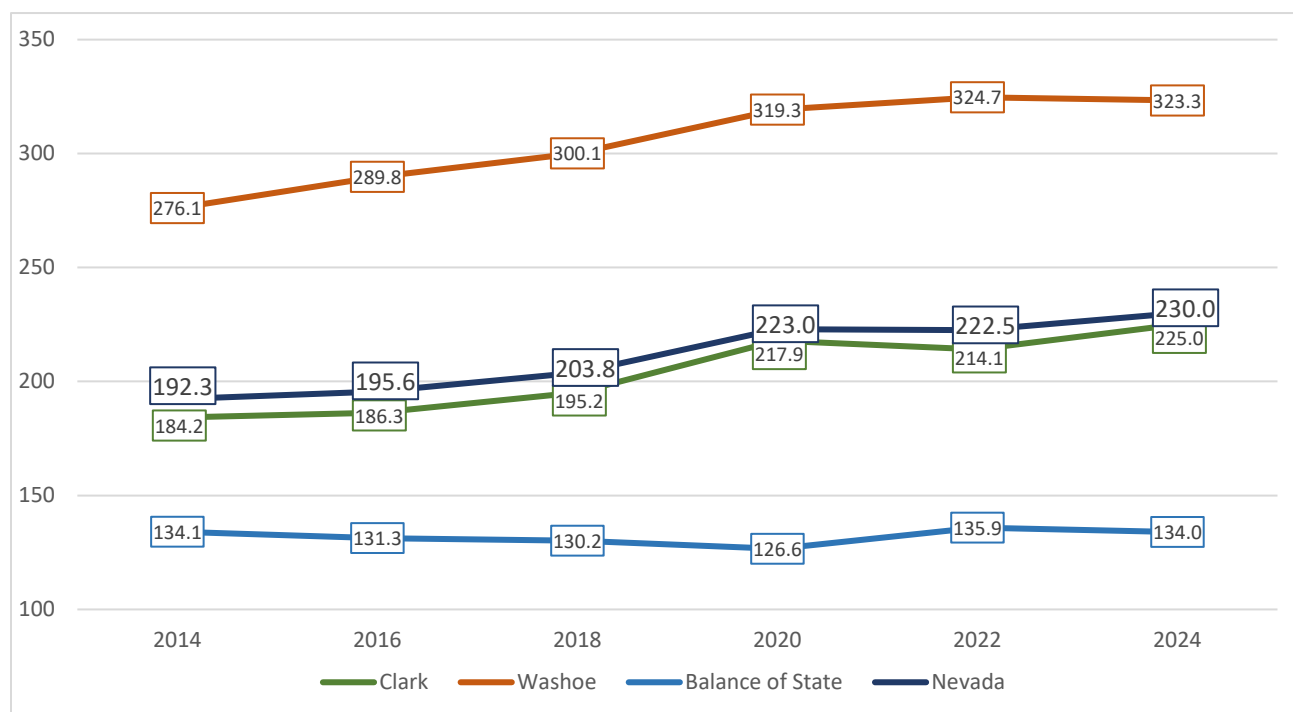

Figure 77: Physicians per 100,000 Population in Nevada – 2014 to 2024



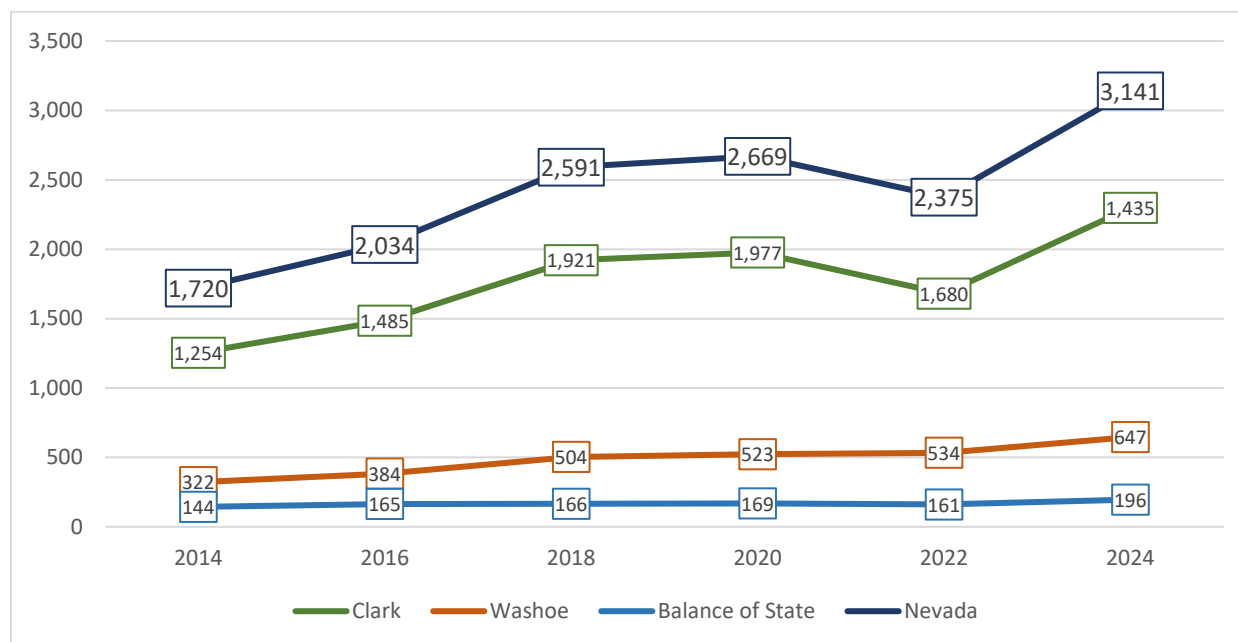

Figure 79: Primary Care Physicians in Nevada – 2014 to 2024

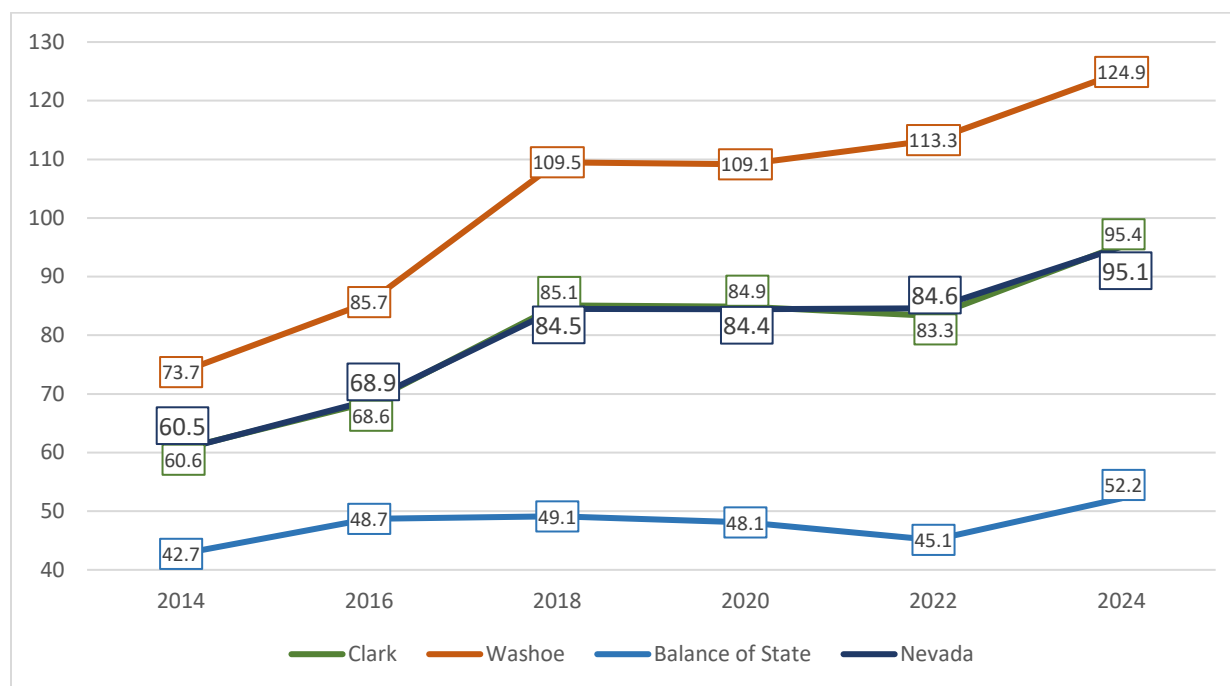

Figure 81: Primary Care Physicians per 100,000 Population in Nevada – 2014 to 2024

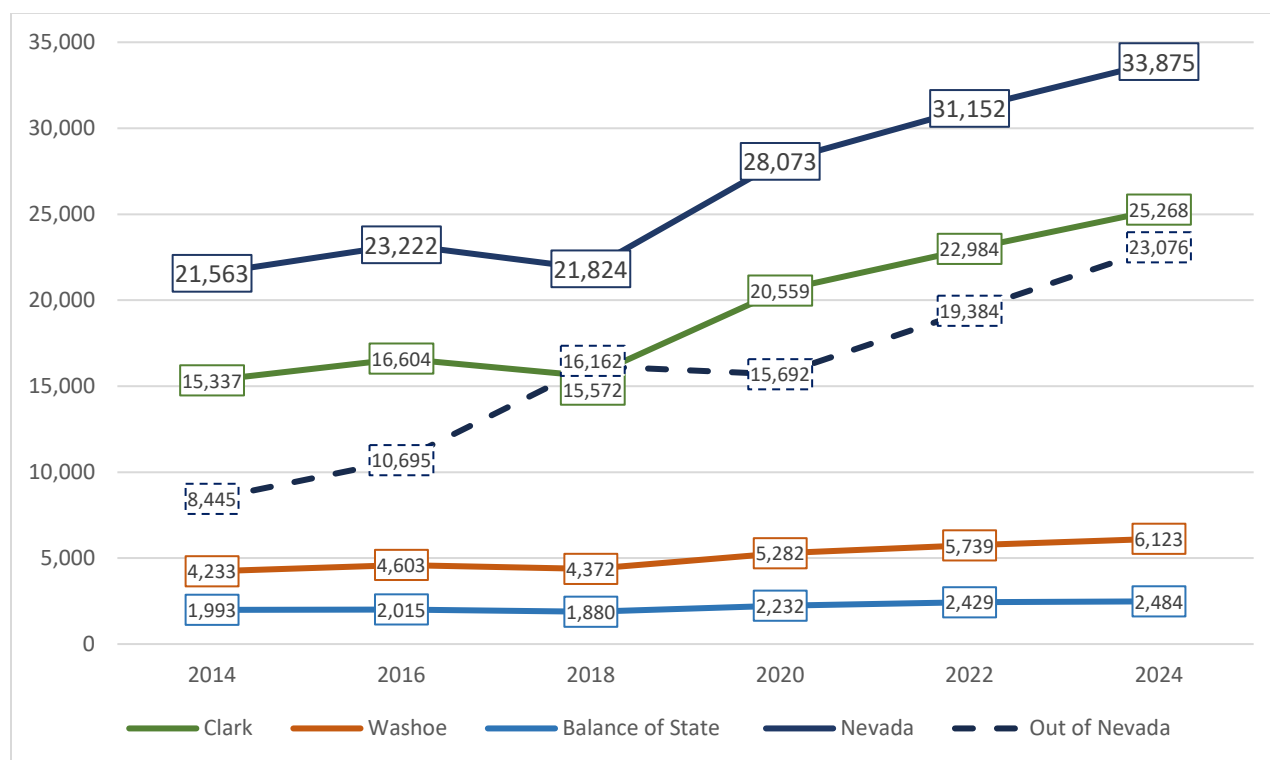

Figure 83: Registered Nurses in Nevada – 2014 to 2024



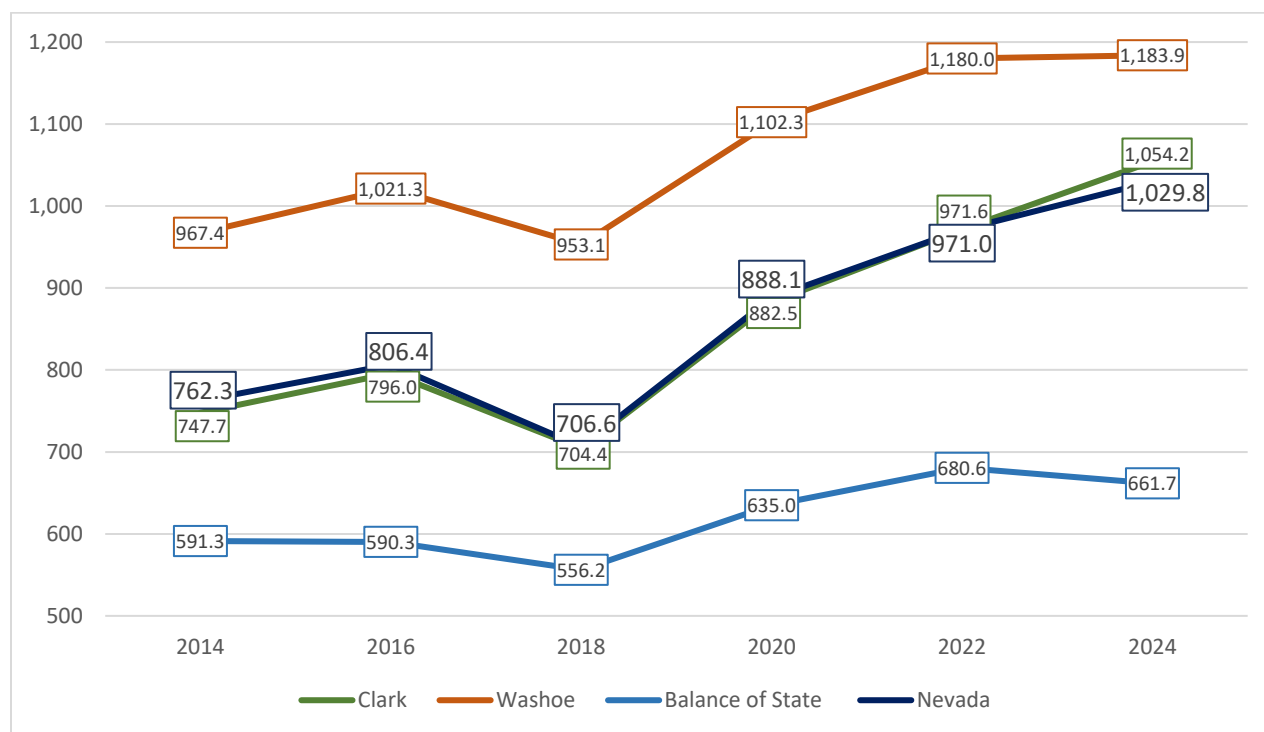

Figure 85: Registered Nurses per 100,000 Population in Nevada – 2014 to 2024



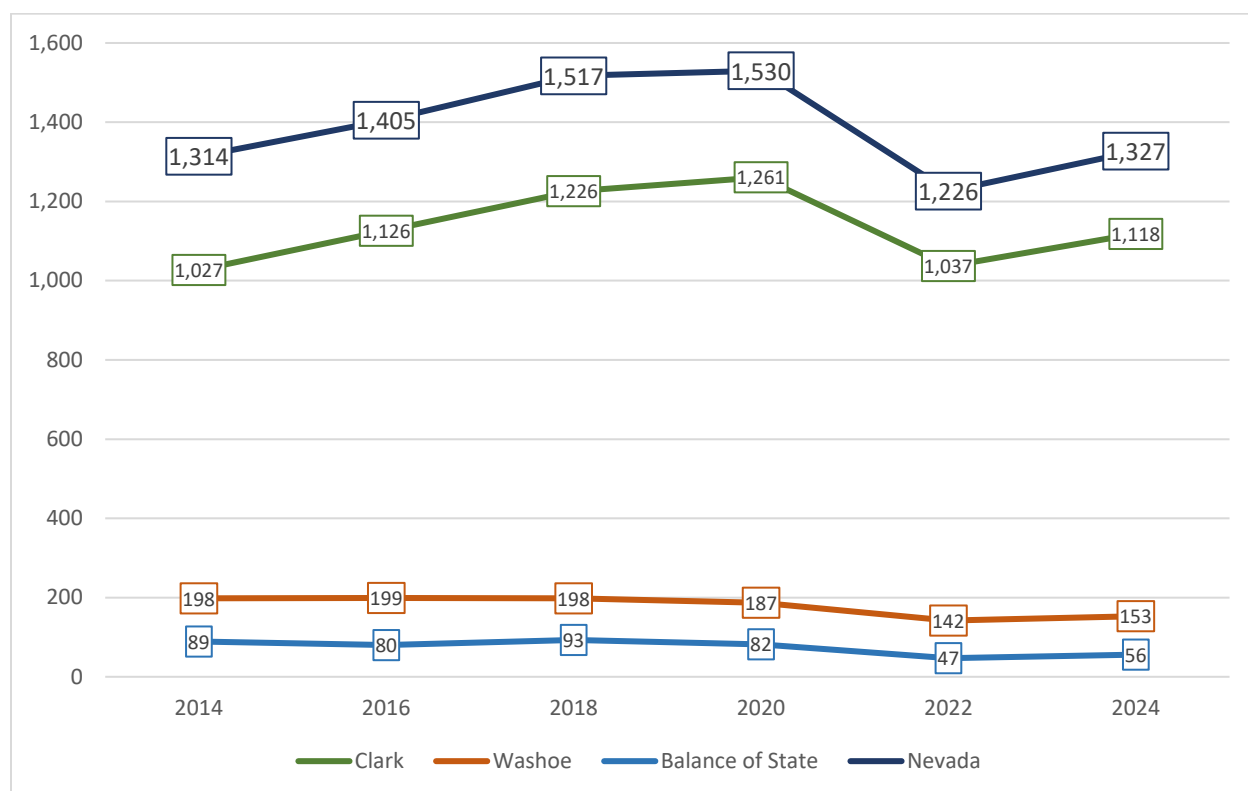

Figure 87: Licensed Respiratory Therapists in Nevada – 2014 to 2024

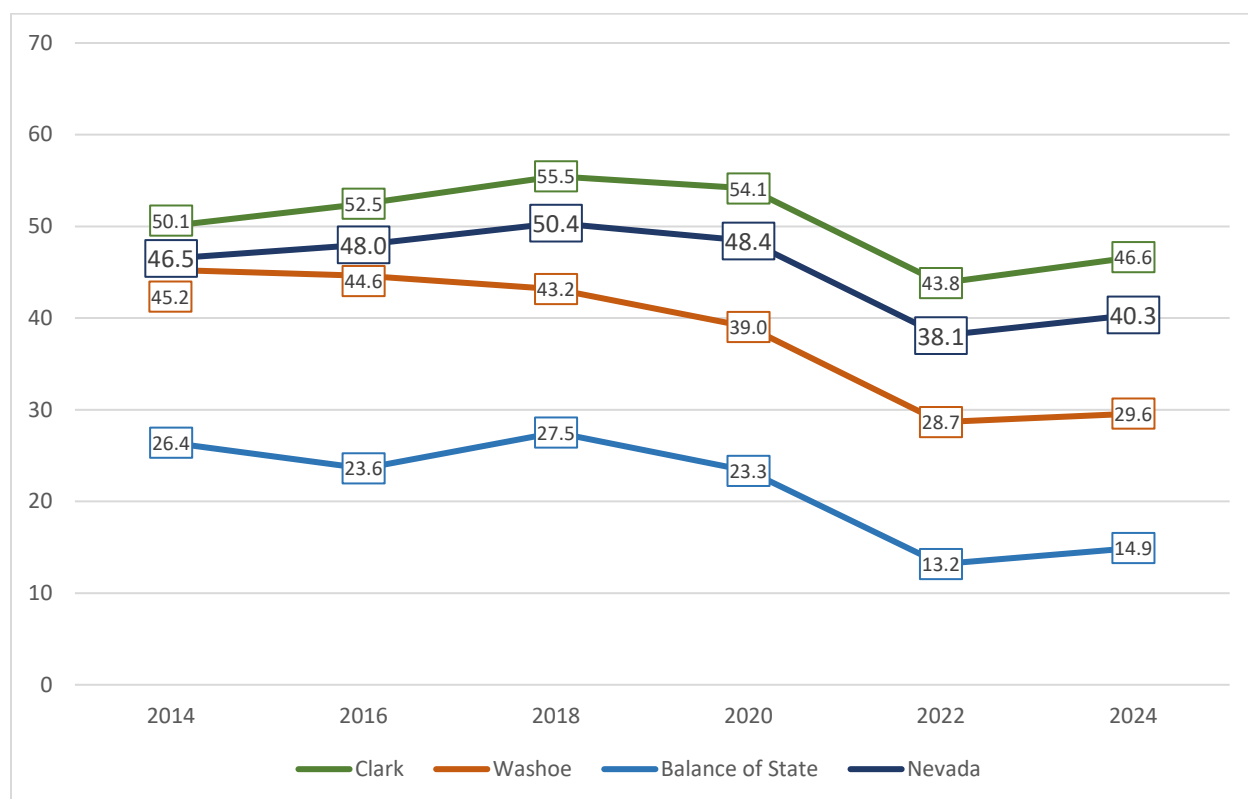

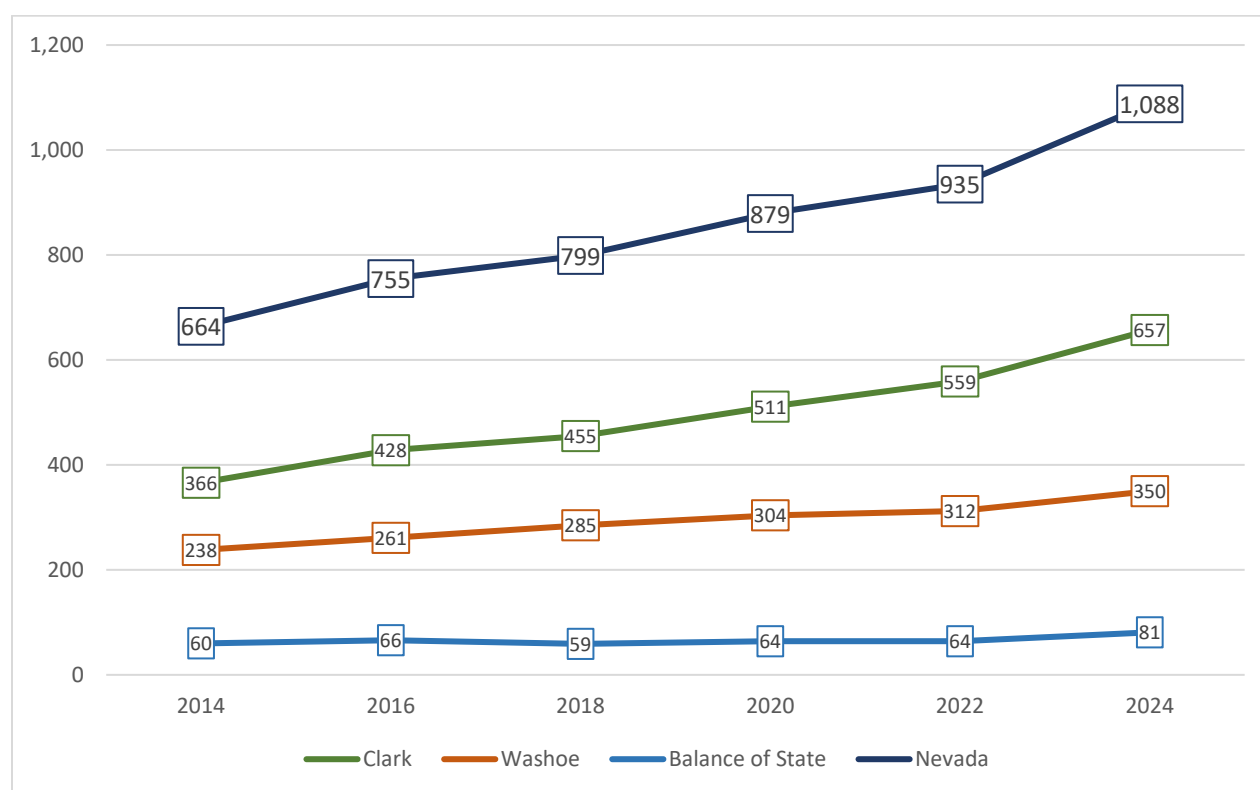
Figure 89: Respiratory Therapists per 100,000 Population in Nevada – 2014 to 2024

Figure 91: Speech-Language Pathologists in Nevada – 2014 to 2024

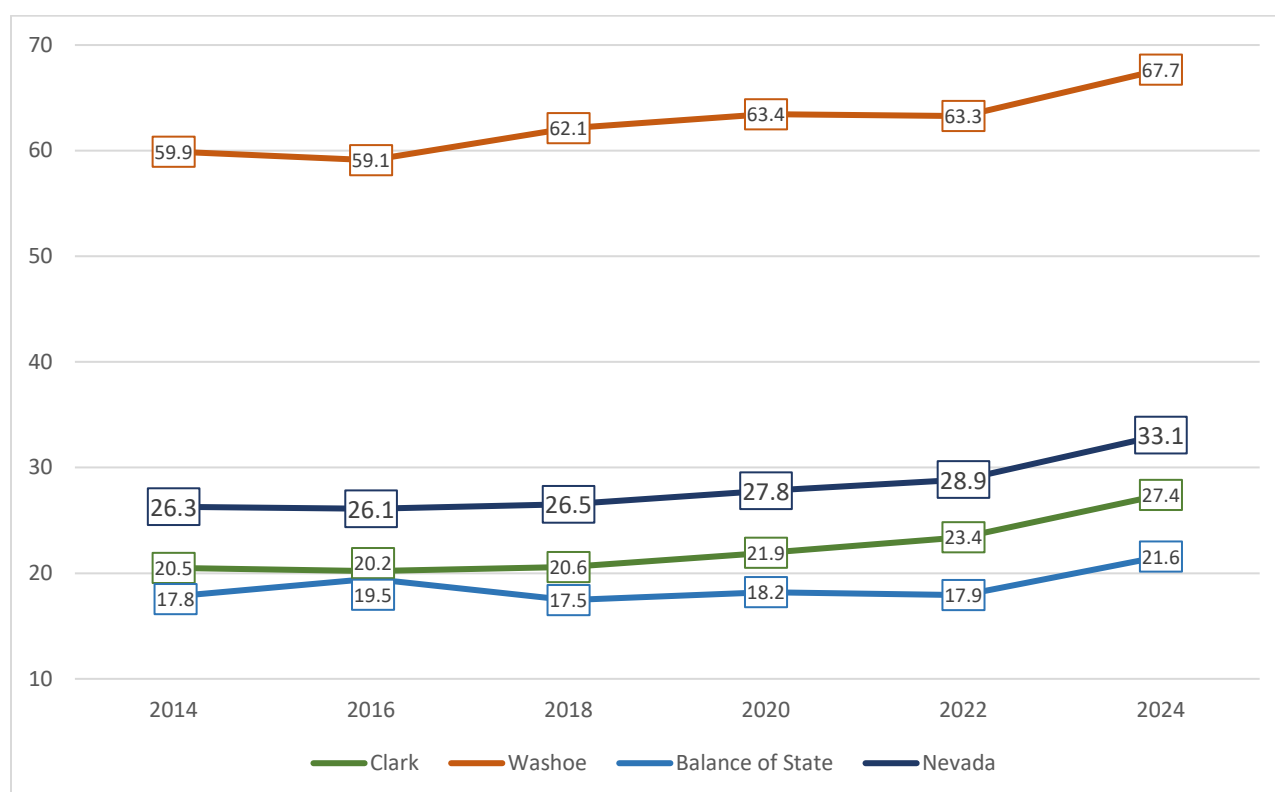

in Nevada – 2025**

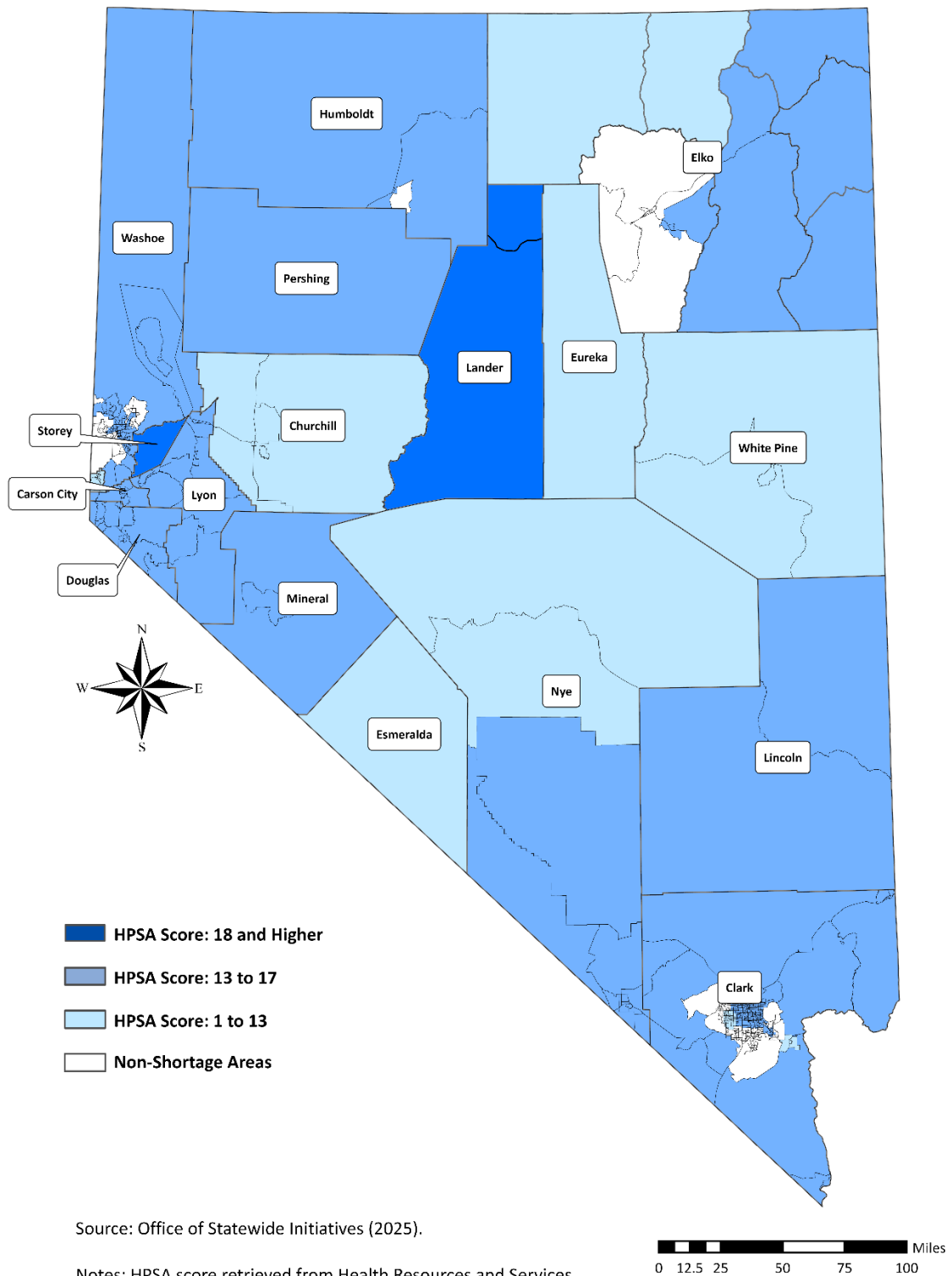


Figure 97: Primary Medical Care Health Professional Shortage Areas (HPSAs) in Southern Nevada – 2025

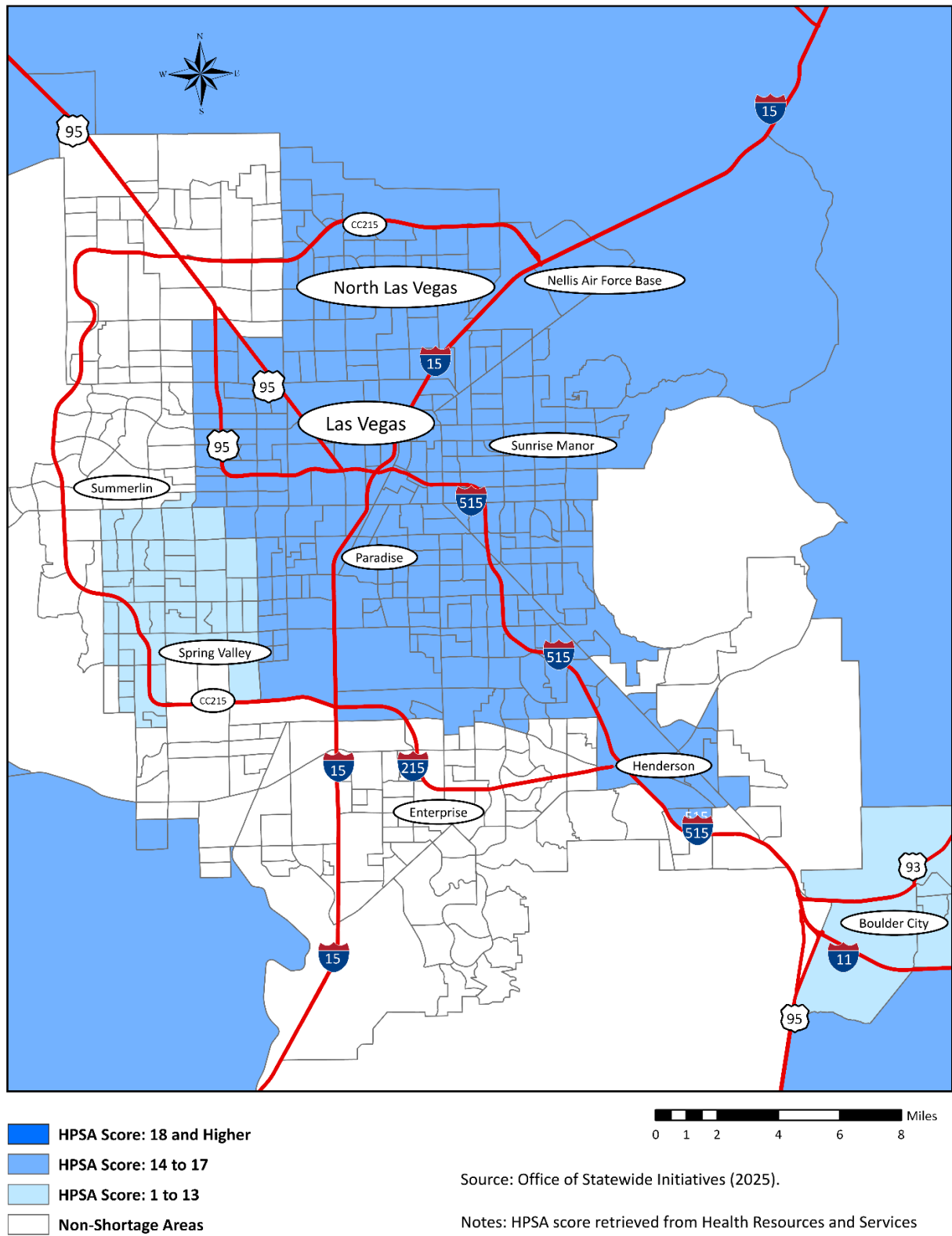


Figure 98: Primary Medical Care Health Professional Shortage Areas (HPSAs) in Northern Nevada – 2025

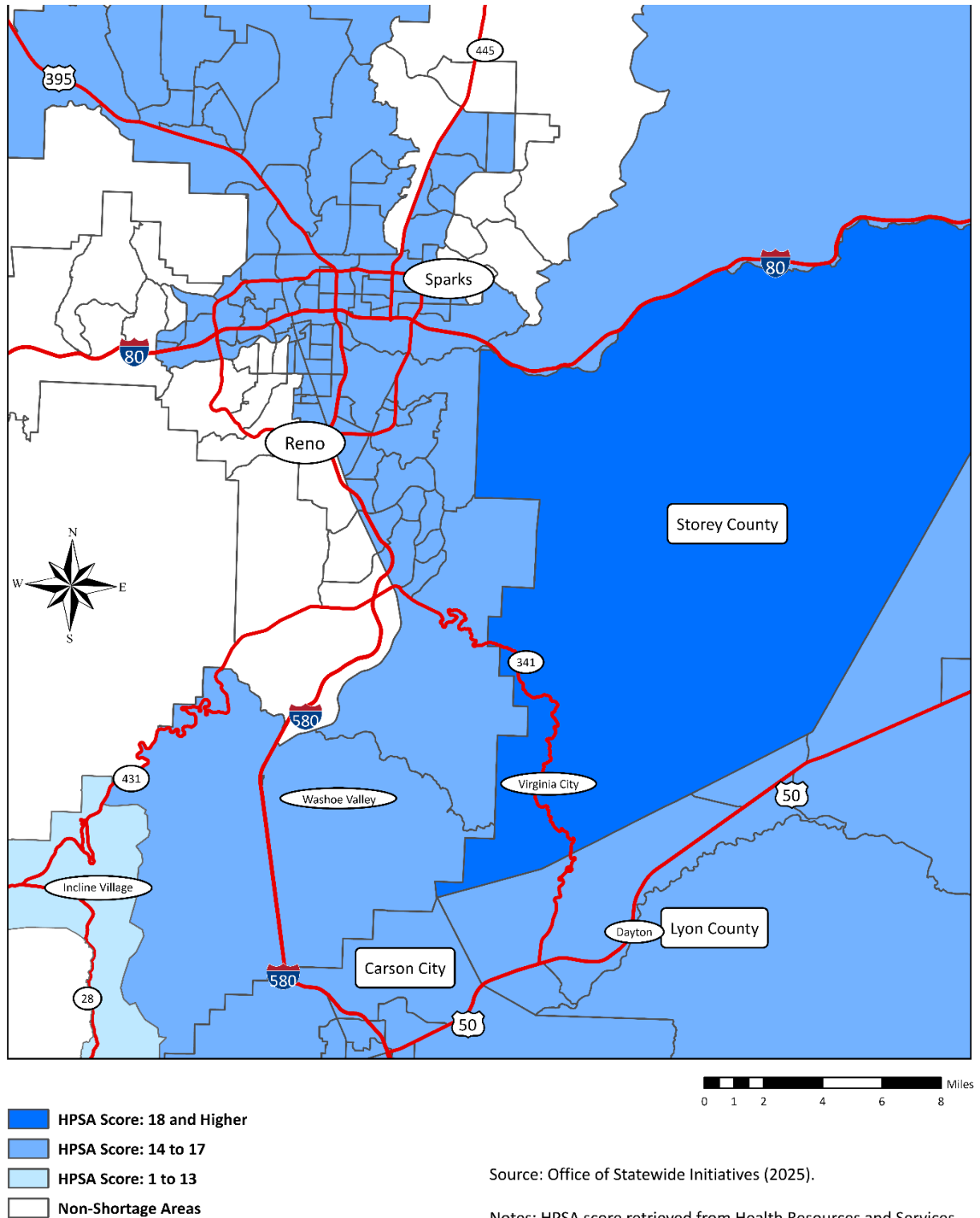


Figure 99: Dental Health Professional Shortage Areas (HPSAs) in Nevada – 2025

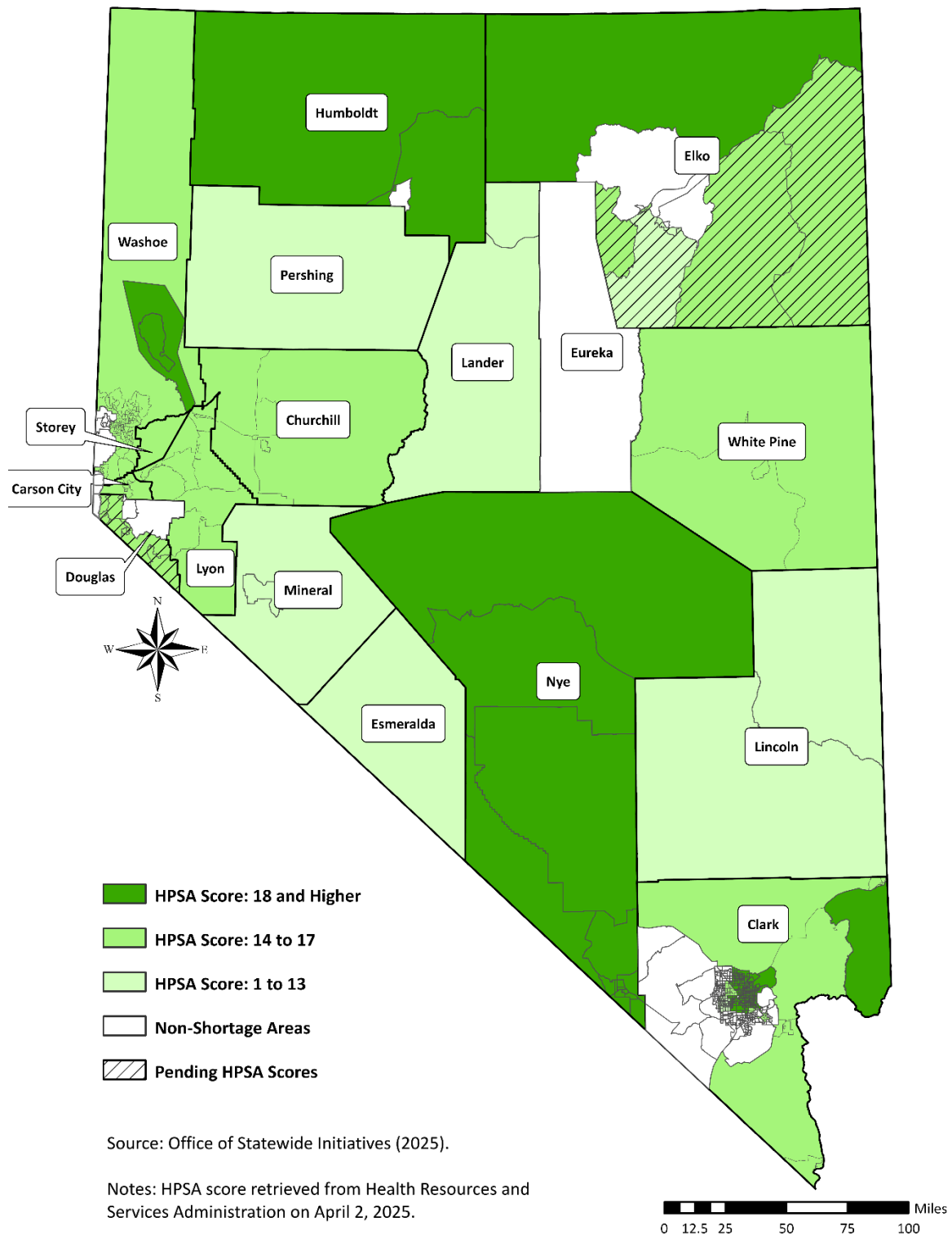


Figure 100: Dental Health Professional Shortage Areas (HPSAs) in Southern Nevada – 2025

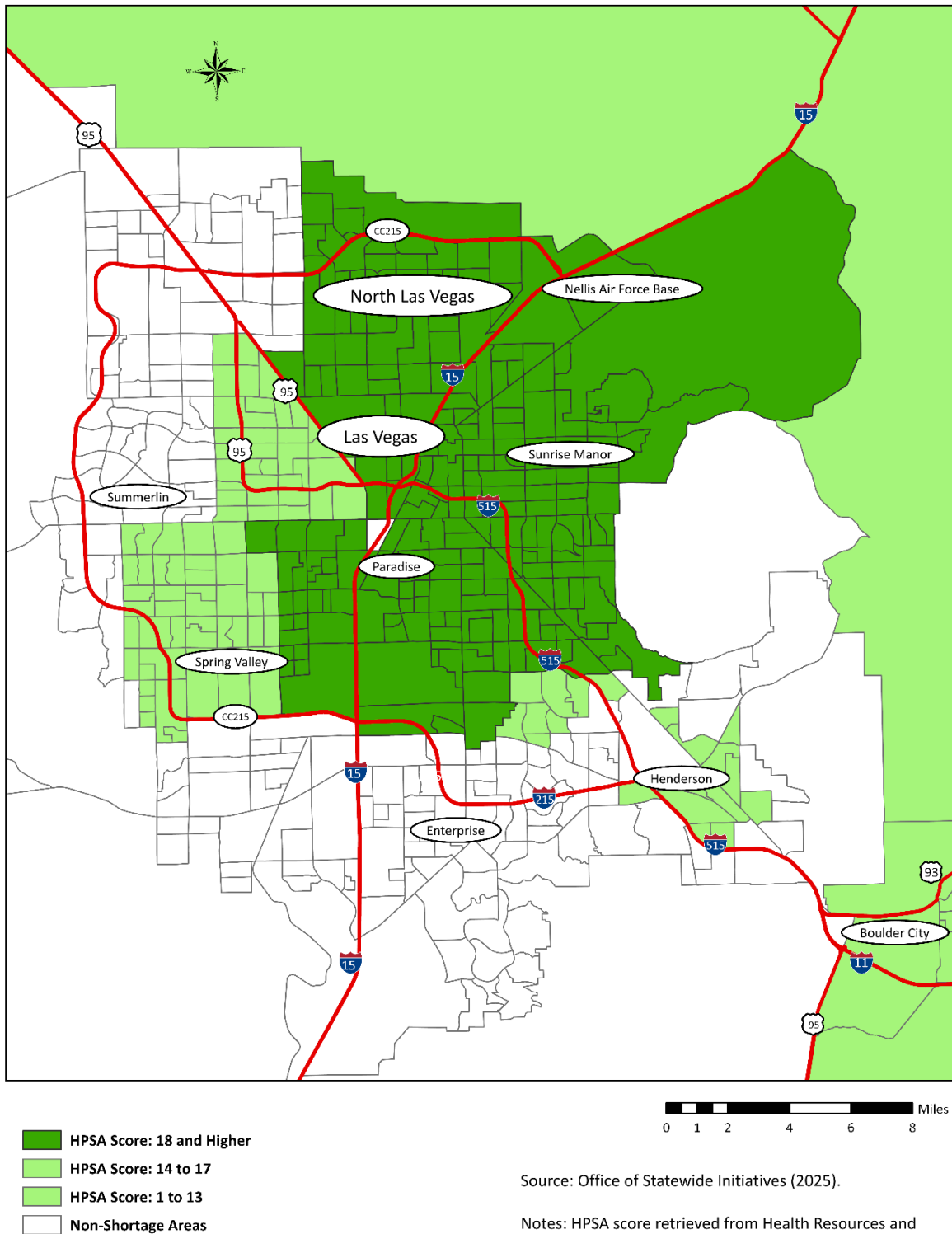
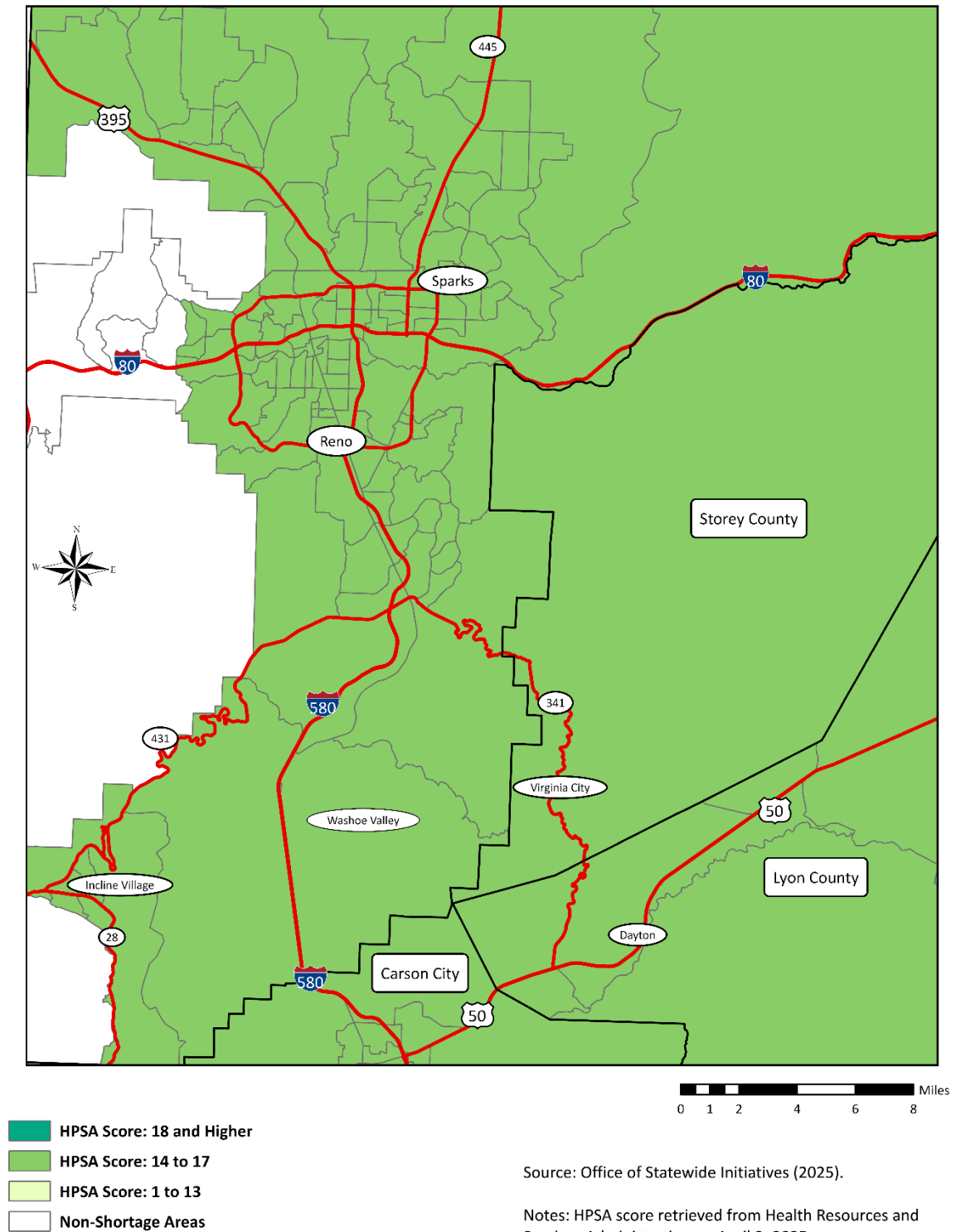
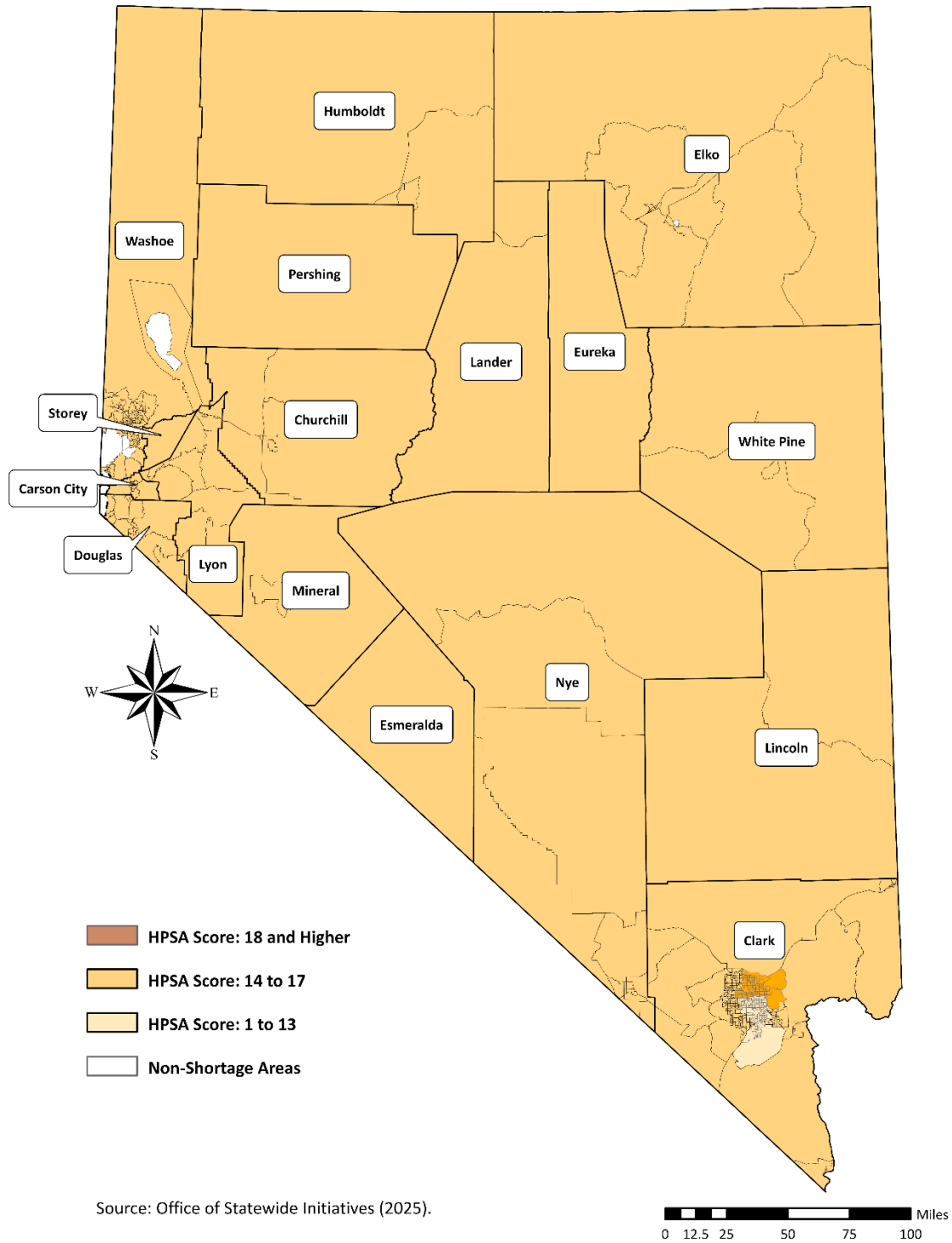


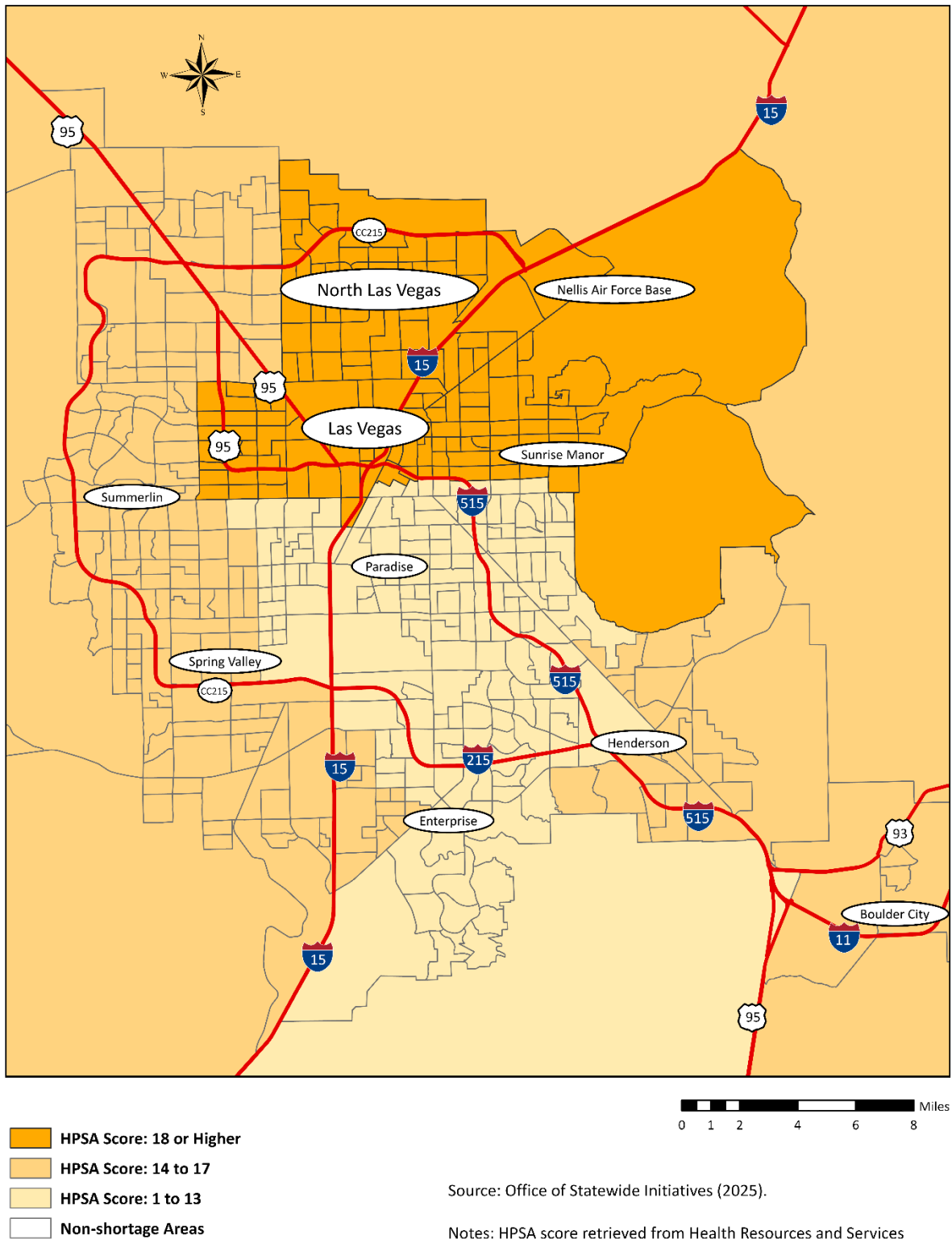
Figure 101: Dental Health Professional Shortage Areas (HPSAs) in Northern Nevada – 2025

in Northern Nevada – 2025**

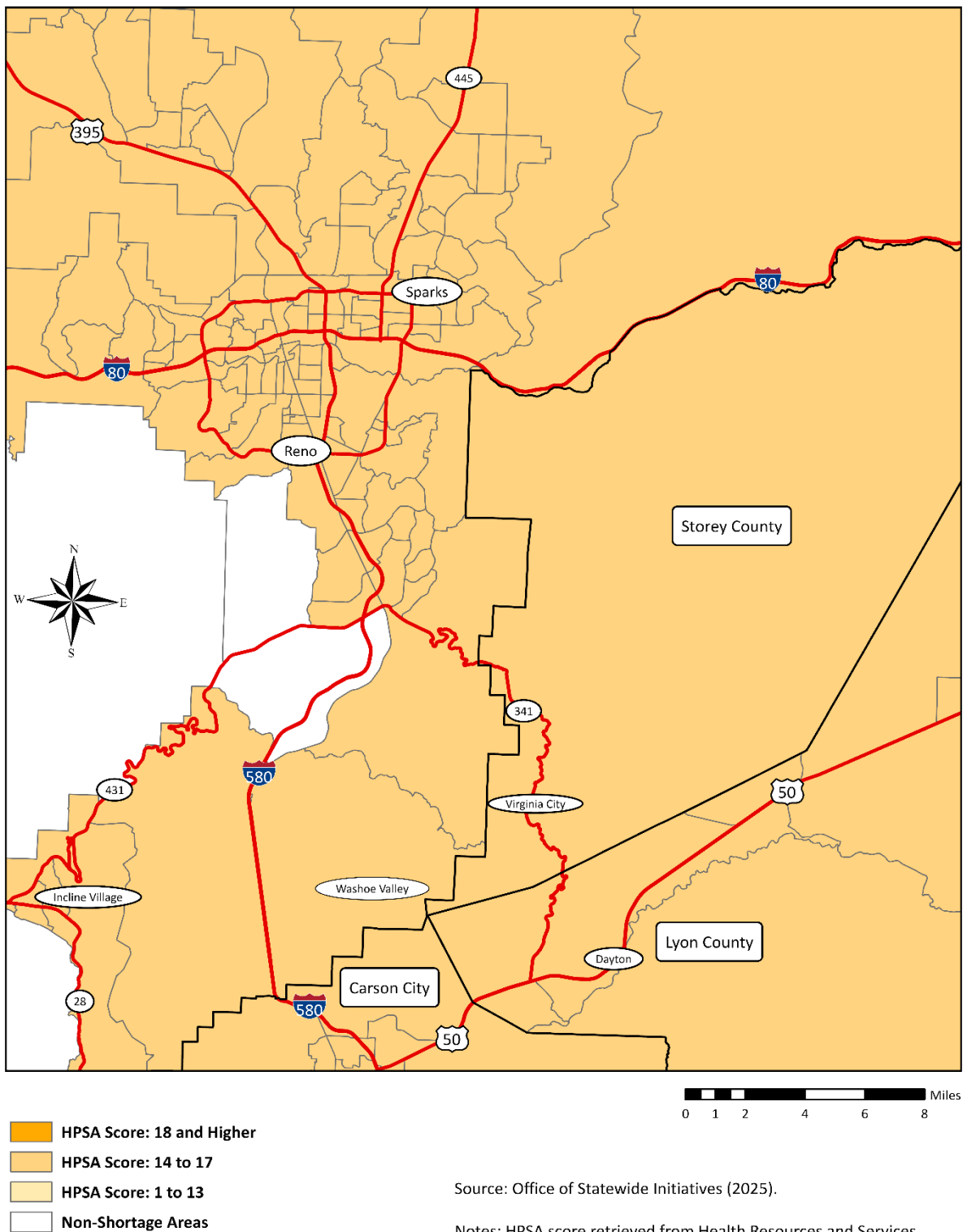


Figure 105: Estimated Population Residing in Health Professional Shortage Areas (HPSAs) in Nevada — 2025
